APPLICANT'S STATEMENT OF THE CASE

In Case No. 20961, Permian seeks an order approving disposal into the Devonian-Silurian formation through the Ramrod Fee SWD #1 well. Permian proposes to drill this well at a

surface location 323 feet from the South line and 2,227 feet from the East line of Section 17, Township 21 South, Range 28 East, NMPM, Eddy County, New Mexico. The target injection interval is the Devonian-Silurian formation at a depth of 12,851' to 13,530'. Permian further seeks approval of the use of 7 inch tubing inside the surface and immediate casings, and 5½ inch tubing inside the liner, and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.
