APPLICANT'S STATEMENT OF CASE


Centennial seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 1 and 12, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico. Centennial proposes to dedicate the above-referenced spacing unit to the following proposed initial wells: (1) the **Pac-Man 36 Fed Com #601H Well** (API No. 30-025-46434) to be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) of Section 36, Township 22 South, Range

34 East, to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 12; (2) the **Pac-Man 36 Fed Com #602H Well** (API No. 30-025-46435), and (3) the **Pac-Man 36 Fed Com #603H Well** (API No. 30-025-46436), both to be horizontally drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 36, Township 22 South, Range 34 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 12. The completed interval for the **Pac-Man 36 Fed Com #602H Well** will remain within 330 feet of the E/2 W/2 of Sections 1 and 12 to allow inclusion of this acreage into a standard 640-acre horizontal spacing unit.
