STATEMENT OF THE CASES

APPLICANT

Case No. 20957: Applicant seeks an order pooling the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2W/2 of Section 12 and the NW/4NW/4 of Section 13, Township 21 South, Range 32 East, NMPM. The unit will be dedicated to the Big Moose Fed. Com. Well Nos. 505H, 506H, and 604H, with first take points in the NW/4NW/4 of Section 12 and last take points in the NW/4NW/4 of Section 13. The wellbore of the Big Moose Fed. Com. Well No. 505H will be located 1254 feet from the west line of Sections 12 and 13, and applicant requests approval thereof.

Case No. 20958: Applicant seeks an order pooling the Wolfcamp formation underlying a horizontal spacing unit comprised of the W/2W/2 of Section 12 and the NW/4NW/4 of Section 13, Township 21 South, Range 32 East, NMPM. The unit will be dedicated to the Big Moose Fed. Com. Well No. 707H, with a first take point in the NW/4NW/4 of Section 12 and a last take point in the NW/4NW/4 of Section 13.

Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.


