1 HEARING EXAMINER LOWE: We are going to skip the

- 2 next two cases until later. We are now going to hear, call
- 3 Case Number 20825, Goodnight for salt water disposal. Call
- 4 for appearance.
- 5 MR. RANKIN: Good morning, Mr. Examiner. Adam
- 6 Rankin on behalf of the applicant in this case. I'll be
- 7 presenting this case by affidavit.
- 8 MS. ANTILLON: Andrea Antillon on behalf of the
- 9 State Land Office. I do not have any witnesses today. I'm
- 10 just here to make a statement.
- 11 HEARING EXAMINER LOWE: You may proceed.
- MR. RANKIN: Thank you, Mr. Examiner.
- 13 In front of you is an exhibit packet containing
- 14 the Exhibits A, B and C, along with the attachments to those
- 15 exhibits.
- 16 Exhibit A is an affidavit from Mr. Nathan Alleman
- 17 who has a previously testified before the Division and had
- 18 his credentials as an expert in regulatory matters, salt
- 19 water disposal permitting, accepted.
- 20 In this case Goodnight Midstream seeks authority
- 21 to inject produced salt water for purposes of disposal to
- 22 the proposed Verlander SWD Number 1 well which will be
- 23 located in Unit H Section 12, Township 21 South, Range 36
- 24 East, In Lea County, New Mexico.
- 25 Mr. Alleman testifies about the operational

- 1 parameters for the proposed injection well. Attached to his
- 2 affidavit as Exhibit 1 is a copy of the C-108 that was filed
- 3 with the Division administratively.
- 4 In his affidavit he reviews the notice that was
- 5 provided in the administrative application, and explains
- 6 that, in this case, the State Land Office has objected to
- 7 the administrative approval of the application. And then he
- 8 reviews the, the area -- identifies the area of review for
- 9 the application, as well as identifies water samples and
- 10 other matters that relate to the C-108.
- 11 Exhibit B is affidavit of the Mr. Steven Allen
- 12 Drake who's a geologist. He's previously testified before
- 13 the Division and reviews the proposed injection interval,
- 14 the geology overlying and underlying seals that will contain
- 15 the injection fluids, as well as the sources of fresh water
- 16 in the area. He testifies in his opinion that the water
- 17 will be contained within the zones that they are proposing
- 18 to inject into.
- 19 Exhibit C is the affidavit of Mr. Thomas Tomastik
- 20 who has previously testified before the Division and had his
- 21 credentials as an expert in petroleum geology and in
- 22 engineering accepted.
- 23 Mr. Tomastik testifies about the operational and
- 24 parameters of the well, as well as the wellbore construction
- 25 and reviews the key elements of the C-108 in his testimony,

1 as well as the area of review testifies, in his opinion, the

- 2 injection to this well under its proposed construction will
- 3 not impair or harm any correlative rights or other sources
- 4 of fresh water in the area.
- With that, I believe all the information
- 6 contained within the C-108 and affidavits satisfies the
- 7 Division's requirement for a C-108 authorization to inject,
- 8 and I would move the admissions of Exhibit A, B, C -- oh,
- 9 one other thing I want to mention.
- 10 The last tab on the exhibit packet, Number 2, is
- 11 an affidavit prepared by me and my office, reflecting that
- 12 notice was provided under cover letter identified in that
- 13 exhibit to the sole protestant in this case, the State Land
- 14 Office, indicating they did actually receive notice of
- 15 today's hearing as well.
- 16 So with that, Mr. Examiner, I would move the
- 17 admission of Exhibits A, B and C, as well as the attachments
- 18 for the record.
- 19 MS. ANTILLON: No objection.
- 20 HEARING EXAMINER LOWE: Okay. Exhibits A, B and
- 21 C and all attachments will be accepted for this record.
- 22 (Exhibits A, B and C admitted.)
- 23 MR. RANKIN: With that, we ask that the case be
- 24 taken under advisement.
- 25 MS. ANTILLON: The State Land Office just has a

- 1 comment to make on this case that it is reviewing the
- 2 application and has concerns with the salt water disposal
- 3 well spacing due to its close proximity to the state trust
- 4 land.
- 5 MR. RANKIN: With that, Mr. Examiner, I would ask
- 6 that this case be taken under advisement.
- 7 HEARING EXAMINER LOWE: Ms. Murphy?
- 8 EXAMINER MURPHY: So how close is it to the state
- 9 trust land?
- 10 MS. ANTILLON: Within half a mile.
- 11 EXAMINER MURPHY: To the east or north?
- 12 MS. ANTILLON: I believe we are to the east. The
- 13 state trust land is to the east.
- 14 EXAMINER MURPHY: It's a quarter mile; right?
- 15 MS. ANTILLON: I can't confirm the exact footage.
- 16 I can get that information for you and mail it to you.
- 17 EXAMINER MURPHY: No, I mean, I can see it on the
- 18 C-102. And the Verlander hasn't changed it's location at
- 19 all?
- 20 MR. RANKIN: No. The location is identified in
- 21 the C-108 along with the lat-long, the current proposal
- 22 location.
- 23 EXAMINER MURPHY: All righty. Thank you.
- 24 EXAMINER GOETZE: I have no questions.
- MR. AMES: No.

Page 7 HEARING EXAMINER LOWE: I have no questions at this time. MR. RANKIN: Thank you very much, Mr. Examiner. We ask that the case be taken under advisement. HEARING EXAMINER LOWE: Case Number 20825 will be taken under advisement. (Case 20825 taken under advisement.)
