1 HEARING EXAMINER LOWE: We will call case Number

- 2 20836, COG for compulsory pooling. Call for appearance.
- 3 MR. RODRIGUEZ: Good morning, Michael Rodriguez
- 4 for COG LLC, and I intend to present this case by affidavit.
- 5 HEARING EXAMINER LOWE: You may proceed.
- 6 MR. RODRIGUEZ Good morning. In this case COG
- 7 seeks an order pooling all interest in the Bone Spring
- 8 formation underlying a standard 1280 acre, more or less,
- 9 horizontal spacing unit comprised of all Sections 21 through
- 10 28, Township 25 South, Range 29 East, Eddy County, New
- 11 Mexico.
- 12 If we turn to Exhibit A, this is the affidavit of
- 13 Monica Beal in support of Case Number 20836. Ms. Beal
- 14 describes her work as a landman. Although she has not
- 15 previously testified before the Division, she states her
- 16 experience and education in her affidavit, and her resume is
- 17 also included as Exhibit A-4 which is in the packet, which
- 18 is the last page of Exhibit A. She is familiar with the
- 19 application and unaware of any opposition to this case, nor
- 20 does she expect any opposition.
- 21 The proposed spacing unit will also be dedicated
- 22 to the Admiral Fed Com 501H, 502H, 503H, 504H, and 505H
- 23 wells. This proposed unit incorporates the proximity
- 24 acreage under the horizontal well rule, a standard 1280 acre
- 25 spacing unit that complies with the division setback

- 1 requirements.
- 2 Referencing Ms. Beal's affidavit are the
- 3 following exhibits: Exhibit Al are the C-102s for the five
- 4 wells dedicated to the proposed spacing unit.
- 5 Exhibit A-2 is the plat that identifies the
- 6 tracts of land for the spacing unit, the interests within
- 7 the unit, and the parties that COG seeks to pool.
- 8 Exhibit A-3 is a sample well proposal letter
- 9 along with THE AFEs for the five proposed wells that were
- 10 sent to the working interest owners.
- 11 If we turn to Exhibit B, this is the affidavit of
- 12 Mr. Travis Sparks. Mr. Sparks works at COG as a geologist.
- 13 He has testified before the Division and had his credentials
- 14 accepted as an expert petroleum geologist. He is familiar
- 15 with the application filed by COG in this case, and
- 16 conducted a geologist study of the target intervals.
- In reference to his exhibits are the following:
- 18 Exhibit B-1 is a project locator map that reflects COG's
- 19 acreage in yellow, the pads of proposed wells depicted by
- 20 dashed orange lines, and the existing producing wells in the
- 21 Second Bone Spring intervals are represented by solid orange
- 22 line.
- 23 Exhibit B-2 is a structure map for the base --
- 24 that's for the base of the Second Bone Spring interval that
- 25 is representative of the target interval within the Bone

- 1 Spring formation.
- 2 And Exhibit B-3 is an overlay, a cross section
- 3 line in red, consisting of three wells penetrating the Bone
- 4 Spring formation that Mr. Sparks used to construct this
- 5 stratigraphic cross section from A to A prime. He also
- 6 considered these well logs are representative of the geology
- 7 in the area.
- Finally Exhibit B-4 is a stratigraphic cross
- 9 section using the representative wells in Exhibit B-3.
- 10 If we turn to Exhibit C, this is an affidavit
- 11 signed by me confirming that notice was provided to the
- 12 working interest owners to be pooled in this case, followed
- 13 by the green cards. And the last page of the exhibit is the
- 14 publication that was published in the Carlsbad Current
- 15 Argus.
- 16 And with that I ask that Exhibits A, B and C be
- 17 admitted into the record and that Case 20836 be taken under
- 18 advisement.
- 19 HEARING EXAMINER LOWE: Exhibits A, B and C will
- 20 be accepted for the case.
- 21 (Exhibits A, B, C admitted.)
- MR. RODRIGUEZ Thank you.
- 23 HEARING EXAMINER LOWE: Do you have any
- 24 questions?
- 25 EXAMINER MURPHY: Thank you, and please send me

- 2 MR. RODRIGUEZ I believe we sent this to you.

- 5 these to me as a PDF.
- 6 MR. RODRIGUEZ I will follow up with that.
- 7 HEARING EXAMINER LOWE: Eric?
- 8 MR. AMES: Nothing.
- 9 HEARING EXAMINER LOWE: Where did you say her
- 10 resume was located at?
- MR. RODRIGUEZ: It should be at the back, the
- 12 last page of --
- 13 HEARING EXAMINER LOWE: Oh, the last page.
- MR. RODRIGUEZ -- of A, yes. So if you flip to B
- 15 and then go back a page, it should be there.
- 16 HEARING EXAMINER LOWE: Okay. That's where it's
- 17 at. We will take Case Number 20836 under advisement.
