1 HEARING EXAMINER LOWE: We will call case Number

- 2 20854 COG for compulsory pooling. Call for appearance.
- 3 MS. LUCK: Katelyn Luck on behalf of the COG
- 4 Operating LLC.
- 5 HEARING EXAMINER LOWE: You may proceed.
- 6 MS. LUCK: Thank you. And COG has requested that
- 7 Cases 20854 and 20855 be consolidated for hearing. And our
- 8 exhibits and affidavits we'll be presenting apply to both
- 9 cases.
- 10 HEARING EXAMINER LOWE: That's fine.
- 11 MS. LUCK: Okay. Thank you. Behind Tab A is the
- 12 affidavit of Grant Bohls in support of both cases. And in
- 13 these cases -- in 20854 COG is seeking to create a Bone
- 14 Spring spacing unit comprised of 640 acres in the E/2 of
- 15 Sections 1 and 12, Township 20 South, Range 33 East, Lea
- 16 County, New Mexico.
- In Case Number 20855, it's the same acreage, but
- 18 COG is seeking to create a spacing unit in the Wolfcamp
- 19 formation, so these are both in the E/2.
- 20 And behind Tab A-1 you will find the C-102s for
- 21 the Bone Spring wells, that's A-1 and A-2.
- 22 And then behind Tab A-3 is a tract map reflecting
- 23 the acreage involved in the breakdown of the interest owners
- 24 in the Bone Spring unit.
- 25 And then behind Tab A-4 is the C-102 for the

- 1 701-H well, which is the Wolfcamp well.
- 2 Behind his Tab A-5 is a tract map again, but for
- 3 the Wolfcamp unit, and then it also highlights the parties
- 4 that COG is seeking to pool in this case.
- 5 Finally behind his A-6 are the well proposal
- 6 letters for both cases, together with the AFE that was
- 7 proposed prior to applying for this pooling hearing.
- 8 Mr. Bohls finally notes in his affidavit that COG
- 9 is seeking overhead and administrative rates of 7000 per
- 10 month while drilling and 700 while producing. And he also
- 11 requests 200 percent charge for the risk involved for any
- 12 non-consenting parties.
- 13 Now Exhibit B is the affidavit of Allison Holcomb
- 14 in support of both. She provides project locator maps as
- 15 her B-1 spacing unit for both of these cases and nearby
- 16 wells producing for both the Bone Spring and Wolfcamp.
- 17 She then provides behind Exhibit B-2 her
- 18 structure map for the Bone Spring. And then behind -- I'm
- 19 sorry, that's for the Second Bone Spring.
- 20 And behind B-3 is for the Third Bone Spring.
- 21 And then behind her Tab B-4 is the structure map
- 22 for the Wolfcamp.
- 23 And behind B-5 is the cross section map for the
- 24 cross section that's behind B-6.
- 25 Ms. Holcomb notes in her affidavit that the

- 1 standup orientation of these wells is the preferred
- 2 orientation for horizontal well development in the area and
- 3 is appropriate to efficiently and effectively develop the
- 4 acreage in both the Bone Spring and Wolf Camp Formations.
- 5 And then finally, our Exhibit C is an affidavit
- 6 by me reflecting that our office provided notice of this
- 7 hearing to the parties to be pooled, and we also include an
- 8 affidavit of publication for both cases because there was a
- 9 few of the notice of hearing letters that were not received
- 10 at the time of this hearing, so as an abundance of caution,
- 11 we published the hearing as well.
- 12 So with that, we would ask that Exhibits A, B, C
- 13 be admitted into the record and both of these cases be taken
- 14 under advisement.
- 15 HEARING EXAMINER LOWE: Exhibits A, B, C will be
- 16 accepted for this case. Any questions?
- 17 (Exhibits A, B and C admitted.)
- 18 EXAMINER MURPHY: There is no unit stipulation?
- 19 MS. LUCK: Those are found behind A-3 and A-5.
- 20 So A-3 is for the first case, 20854, and that has a
- 21 breakdown of the working interest owners in the Bone Spring
- 22 unit, as well as the record title owners and the overrides
- 23 that we are seeking to pool.
- 24 And then A-5 has the same breakdown for the
- 25 Wolfcamp formation.

Page 6 EXAMINER MURPHY: Okay. I have no more 1 2 questions. HEARING EXAMINER LOWE: Mr. Goetze? EXAMINER GOETZE: What is the building blocks we 5 are using for the Wolfcamp as far as spacing. 6 MS. LUCK: This is an oil pool that we're for the 701H well, so these are 40-acres. 7 EXAMINER GOETZE: 40 acres, that's fine. 8 9 you. MR. AMES: I have nothing. 10 MS. LUCK: I would also like to note, I didn't 11 submit Exhibit A with the packet, but we will mail it in 12 after the hearing. 13 14 HEARING EXAMINER LOWE: Thank you. Case Numbers 20854 and 20855 will be taken under advisement. 15 16 MS. LUCK: Thank you. 17 HEARING EXAMINER LOWE: Thank you. 18 (Cases 20854 and 20855 taken under advisement.) 19 20 21 22 23 24 25
