1 HEARING EXAMINER LOWE: Call Case Number 20864.

- 2 Call for appearance.
- 3 MS. BENNETT: Good morning. Deana Bennett on
- 4 behalf of Marathon Oil Permian LLC.
- 5 MR. LARSON: Good morning, Mr. Examiner. Gary
- 6 Larson of the Santa Fe office of Hinkle Shanor on behalf of
- 7 BTA Oil Producers. I do not have any witnesses.
- 8 HEARING EXAMINER LOWE: Are you going to present
- 9 by affidavit?
- 10 MS. BENNETT: Yes, and I have conferred with
- 11 counsel for BTA who does not oppose me putting the case on
- 12 by affidavit.
- 13 HEARING EXAMINER LOWE: You may proceed.
- MS. BENNETT: Good morning again. Before you I
- 15 have placed a packet of exhibits for Case Number 20864.
- 16 Case Number 20864 involves the S/2 of the two sections that
- 17 are at issue here, and these are Wolfcamp wells, Upper and
- 18 Lower Wolfcamp wells, six wells total.
- 19 Behind Tab A is the affidavit of Mr. Chase Rice,
- 20 a Marathon landman who has been previously qualified to
- 21 testify before the Division. Behind his affidavit are all
- 22 the terms that Marathon is seeking for the particular wells.
- 23 He also, behind his affidavit, he includes the application
- 24 for Case Number 20864.
- 25 Behind Tab 2 are the C-102s, and the wells are in

- 1 the Purple Sage Wolfcamp Gas Pool, and these wells do not
- 2 comply with the setback requirements for the Purple Sage
- 3 Wolfcamp Gas Pool, and Marathon will be requesting NSL
- 4 approval, non-standard approval separately, and those
- 5 applications are in process. We are in the process of
- 6 compiling the offset owners' addresses. As soon as I have
- 7 those, we will be submitting the NSL application.
- 8 Behind Tab 3 are the lease tract maps -- is the
- 9 lease tract map, as well as the breakdown of working
- 10 interest versus uncommitted working interest.
- Behind Tab 4 is the proposal letter. This
- 12 proposal letter includes wells in both the N/2 and the S/2,
- 13 and the N/2 wells are the subject of the contested hearing
- 14 that we will be having later today or tomorrow.
- 15 The next pages behind Tab 5 are the AFEs, and as
- 16 I previously testified -- Mr. Rice testified -- or as I
- 17 previously stated, Mr. Rice testified, these costs are in
- 18 line with costs that other operators are charging in this
- 19 area of New Mexico.
- 20 Behind Tab 6 is my affidavit of notice which
- 21 includes the notice letters that were sent out. As I
- 22 previously explained, we inadvertently left BLM off the
- 23 initial mailing, so we FedEX'd BLM an overnight letter, and
- 24 that information is also included in this affidavit, as well
- 25 as my affidavit of publication showing we published notice

- 1 of this hearing today.
- 2 Let's see. Behind Tab B is the affidavit of the
- 3 Ms. Rebecca Horne. As I mentioned earlier, she will be
- 4 testifying in the contested hearing, and I will present -- I
- 5 will supplement these exhibits with her resume, but we will
- 6 also be discussing her qualifications when she testifies in
- 7 person later today or tomorrow.
- 8 HEARING EXAMINER LOWE: Okay.
- 9 MS. BENNETT: Behind her affidavit is the locator
- 10 map showing the proposed unit in reference to the Capitan
- 11 Reef, a wellbore schematic. Again, this wellbore schematic
- does show both the N/2 and S/2 wells, but the S/2 wells are
- 13 identified by a red dash box. That's on Page 61.
- 14 Then Ms. Horne has produced two sets -- provided
- 15 two sets of geology studies, one for the Upper Wolfcamp
- 16 wells and one for the Lower Wolfcamp wells. And for each
- 17 study she prepared a structure map, a map showing the
- 18 location of the wells used to create her cross section, the
- 19 cross section and an isochore.
- 20 Behind Tab 11 is a citation from the Snee Zoback
- 21 paper justifying her conclusions about the preferred well
- 22 orientation in this area.
- This application also involves a proximity tract,
- 24 and Mr. Rice testifies about the proximity tract -- excuse
- 25 me -- that's in the application on Page 6 -- I'm sorry --

1 Paragraph 6, which is on Page 7, the completed interval for

- 2 the Valkyrie 12 WXY Federal Com 9H well is less than 330
- 3 feet from the adjoining tract, and the Division's rule
- 4 allows for the proximity tract within the proposed spacing
- 5 for the wells. So that is the, quote-unquote, defining well
- for purposes of the proximity tract rule.
- 7 With that I would ask that Exhibits A and B and
- 8 their attachments be admitted into the record in case Number
- 9 20864.
- 10 HEARING EXAMINER LOWE: Mr. Larson?
- 11 MR. LARSON: No objection.
- 12 HEARING EXAMINER LOWE: Exhibits A and B will be
- 13 accepted for this case.
- 14 (Exhibits A and B admitted.)
- 15 MS. BENNETT: I stand for any questions, if I can
- 16 answer any.
- 17 HEARING EXAMINER LOWE: Ms. Murphy?
- 18 EXAMINER MURPHY: Pardon me, I'm confused, but
- 19 the S/2 is the contested part of this?
- 20 MS. BENNETT: The N/2 is the contested part. The
- 21 S/2 is uncontested.
- 22 EXAMINER MURPHY: Thank you.
- MS. BENNETT: You are welcome.
- 24 HEARING EXAMINER LOWE: Is that it?
- 25 EXAMINER MURPHY: No questions, thank you.

- 1 HEARING EXAMINER LOWE: Mr. Goetze.
- 2 EXAMINER GOETZE: We have six wells for this
- 3 application, and we also have other wells cited in the
- 4 letter to the various parties. I'm assuming they are in the
- 5 other cases?
- 6 MS. BENNETT: They are. We have the Bone Spring
- 7 S/2 wells will be my next presentation, and then for the N/2
- 8 we have Bone Spring -- Bone Spring wells and Wolfcamp wells.
- 9 EXAMINER GOETZE: No further questions. Thank
- 10 you.
- MS. BENNETT: Thank you.
- 12 HEARING EXAMINER LOWE: Of the six wells you
- indicated for this case, are they all unorthodox?
- MS. BENNETT: They are all unorthodox.
- 15 HEARING EXAMINER LOWE: They are all unorthodox?
- 16 MS. BENNETT: Yes. They are all proposed to be
- 17 100 feet from the outer boundary of the spacing unit.
- 18 HEARING EXAMINER LOWE: That's all the questions
- 19 I have.
- 20 MS. BENNETT: Thank with. With that I would ask
- 21 that Case Number 20864 be taken under advisement.
- 22 HEARING EXAMINER LOWE: Case Number 20864 will be
- 23 taken under advisement.
- MS. BENNETT: Thank you.
- 25 (Case 20864 taken under advisement.)
