1 HEARING EXAMINER LOWE: We will call case Number

- 2 20867 and 20868, Marathon for compulsory pooling. Call for
- 3 appearance.
- 4 MS. BENNETT: Good morning. Deana Bennett on
- 5 behalf of Marathon Oil Permian LLC.
- 6 MR. LARSON: Good morning, Mr. Examiner. Gary
- 7 Larson with the Santa Fe office of Hinkle Shanor for BTA Oil
- 8 Producers.
- 9 MS. BENNETT: Good morning. I asked these two
- 10 cases be consolidated for purposes of hearing, and I propose
- 11 to put these two cases on by affidavit, assuming there are
- 12 no objections from BTA.
- MR. LARSON: No objection.
- 14 HEARING EXAMINER LOWE: You may proceed.
- 15 MS. BENNETT: Thank you. I have placed before
- 16 you a single packet for these two cases, Case Number 20867
- 17 and Case Number 20868. These two cases are the Valkyrie
- 18 Second Bone Spring well applications. And again, this is in
- 19 the S/2 uncontested.
- 20 Behind Tab A is the affidavit of Chase Rice, the
- 21 landman from Marathon who has previously testified before
- 22 this Division. And his affidavit identifies all the terms
- 23 that Marathon is seeking included in the order.
- One thing I should note about this case that I
- 25 didn't note about the prior case, but would be equally

1 applicable, Marathon is requesting that overriding royalty

- 2 interest owners be pooled, and those overriding royalty
- 3 interest owners are identified behind Tab 7.
- 4 As with the previous cases, behind Mr. Rice's
- 5 affidavit, I have included the application for the two cases
- 6 for your convenience.
- 7 Behind Tab 3 are the C-102s for the Second Bone
- 8 Spring wells. These wells will be orthodox.
- 9 HEARING EXAMINER LOWE: Okay.
- 10 MS. BENNETT: Behind Tab 4 are the lease tract
- 11 maps and breakdown between committed and uncommitted working
- 12 interest owners, and they run in order. So the first two
- 13 pages are for the 14H well, and the second two pages are for
- 14 the 15H well.
- 15 Behind Tab 5 is the proposal letter which is the
- 16 same proposal letter we just reviewed. Again, it has more
- 17 wells than Marathon proposed, more wells than are currently
- 18 at issue in this particular case. Half of them are in the
- 19 N/2, half are in the S/2, and we will get to the N/2 later
- 20 today or tomorrow.
- 21 Behind Tab 6 are the AFEs for these wells.
- 22 Behind Tab 7 is my notice affidavit with the
- 23 letters that were sent out, and again this includes the Fed
- 24 Ex information for the mailing to BLM, as well as an
- 25 affidavit of publication showing that notice of this hearing

- 1 was published.
- 2 Behind Tab B is the affidavit of Ms. Rebecca
- 3 Horne. I will supplement her exhibit with her resume.
- 4 Behind her affidavit are the slides that one would
- 5 anticipate, the locator map, the wellbore schematic, a
- 6 structure map, a map showing the location of the wells that
- 7 Ms. Horne used for her cross reference -- or for her cross
- 8 section, a cross section, as well as an isochore.
- 9 Finally, behind Tab 11 is a citation to the Snee
- 10 Zoback paper justifying Ms. Horne's conclusions regarding
- 11 the preferred orientation of wells in this area.
- 12 With that I would ask that Exhibits A and B and
- 13 their attachments be admitted into the record in both case
- 14 numbers 20867 and 20868.
- 15 HEARING EXAMINER LOWE: Okay. Any objection?
- MR. LARSON: No objection.
- 17 HEARING EXAMINER LOWE: No objection, Exhibits A
- 18 and B will be accepted for both cases.
- MS. BENNETT: Thank you.
