Page 3 HEARING EXAMINER LOWE: We will call Case Number 1 2 20875, XTO for compulsory pooling. Call for appearance. MR. FELDEWERT: May it please the Examiner, 3 4 Michael Feldewert of the Santa Fe Office of Holland & Hart 5 on behalf of the applicant. 6 HEARING EXAMINER LOWE: Thank you. You may 7 proceed. 8 MR. FELDEWERT: Mr. Examiner, we are presenting 9 this case by affidavit. And Exhibit A is the affidavit of 10 Mr. Brett Woody, and he references the spacing unit that is depicted on Exhibit B-2. And what it involves is what is 11 12 the S/2 of the N/2 equivalent of irregular Section 32 down 13 there along the state line with the Texas. 14 And so they are seeking to create what is a 15 standard horizontal well spacing unit comprised of the four lots that make up this irregular S/2 of the N/2 equivalent. 16 It will be dedicated to a single well, which is the C-102 17 which is provided under Exhibit 1 to Mr. Woody's affidavit. 18 The only party that they seek to pool is WPX 19 Energy Permian, who has lodged no objection to this pooling 20 application. And the well proposal letter that was sent to 21 them is marked as Exhibit Number 3 to his affidavit. 22 And you will see from that letter that they are 23 24 requesting overhead rates of 7,500 per month while drilling 25 and 750 per month while producing. And there are no depth

Page 4 severances in the Bone Spring Formation under this page. 1 Exhibit B is the affidavit of the geologist. 2 She 3 has provided a structure map as Tab 1 to her exhibit, which not only shows a structure in this area, but also the well 4 5 that she -- the four wells that she utilized for a cross 6 section. And you will see the wellbore in the proposed 7 spacing unit kind of in the middle of that, of that exhibit 8 down there towards the bottom of Section 32, that straight 9 line that you see there at the bottom of Section 32. 10 The stratigraphic cross section then is provided 11 as Tab 2 to her affidavit, and she identifies the Second 12 Bone Spring as the target interval, has that shaded across 13 the stratigraphic cross section under Tab 2. 14 She then provides the testimony that it's 15 16 necessary to approve this application from a geologic perspective. 17 Exhibit C is our affidavit confirming that notice 18 of this hearing was provided to WPX and it reflects that WPX 19 did receive actual notice of this hearing. 20 So with that we ask that Exhibits A, B and C be 21 admitted into the record in this matter. 22 23 HEARING EXAMINER LOWE: Exhibits A, B and C will 24 be admitted for the case. 25 (Exhibits A, B and C admitted.)

Mr. Goetze? 7 8 EXAMINER GOETZE: So the witness for geology has not been here before? 9 MR. FELDEWERT: Thank you for pointing that out. 10 She has not. She provides her -- I forgot about that. She 11 does provide in Paragraph 2 her credentials qualifying her 12 13 as an expert in petroleum geology. 14 EXAMINER GOETZE: No further questions. HEARING EXAMINER LOWE: I have no questions at 15 16 this time. Case Number 20875 will be taken under 17 advisement. MR. FELDEWERT: Thank you. 18 19 HEARING EXAMINER LOWE: Thank you.
