1 HEARING EXAMINER LOWE: It's about 9:46. We will

- 2 take a 15-minute break. And then we'll come back and
- 3 reconvene afterwards.
- 4 (Recess taken.)
- 5 HEARING EXAMINER LOWE: We will go back on the
- 6 record. As of recent we are going to move down to
- 7 the Hilcorp case; right?
- 8 MR. AMES: Yes.
- 9 HEARING EXAMINER LOWE: We're going to head down
- 10 to Number 23, which is Case Number 20902, Hilcorp for
- 11 compulsory pooling. Call for appearance.
- MS. LUCK: Kaitlyn Luck on behalf of the
- 13 applicant, Hilcorp. And we are presenting this case by
- 14 affidavit.
- 15 HEARING EXAMINER LOWE: You may proceed.
- 16 MS. LUCK: In this case Hilcorp is providing two
- 17 affidavits.
- 18 Exhibit A is the affidavit of Hilcorp's landman,
- 19 Robert Carlson. He notes in his affidavit that in this case
- 20 Hilcorp is seeking an order pooling all uncommitted interest
- 21 in the Pictured Cliffs formation underlying a standard 160-
- 22 acre spacing unit comprised of the SW/4 of Section 36, and
- 23 dedicating the spacing unit to the State Com M 010 Well and
- 24 designating Hilcorp as operator of the wells.
- 25 This well is currently configured in the

- 1 Mesaverde and Dakota formation and is dedicated to a
- 2 320-acre gas spacing unit comprised of the W/2 of Section
- 3 36.
- 4 In this case Hilcorp intends to recomplete the
- 5 well at a six standard gas well location in the NW/4 of the
- 6 SW/4 of the section. His affidavit provides the location
- 7 for the Pictured Cliff formation where the well will be
- 8 recompleted.
- 9 Behind his Tab A-1 is the C-102 for the well.
- Behind his Exhibit A-2 is a tract map identifying
- 11 the interest owners in the spacing unit, as well as the
- 12 overriding royalty interest owners that Hilcorp seeks to
- 13 pool in this case.
- 14 And then behind his Exhibit A-3 is the well
- 15 proposal letter that was sent to the working interest
- 16 owners, together with an AFE.
- 17 And then behind Exhibit -- and Mr. Carlson notes
- 18 in his affidavit that Hilcorp is seeking an administrative
- 19 overhead cost of 7500 per month while drilling and 750 per
- 20 month while operating the wells.
- 21 And then he also provided our office with the
- 22 uncommitted interest owners' names and addresses, and we
- 23 provided notice of this hearing.
- 24 So behind Exhibit B is an affidavit prepared by
- 25 me reflecting that our office provided notice to the

1 uncommitted interest owners in the spacing unit, and each of

- 2 them received notice of this hearing as reflected on the
- 3 tracking list.
- 4 And with that, that concludes our presentation in
- 5 this case. So we would move the admission of Exhibits A and
- 6 B, together with attachments.
- 7 HEARING EXAMINER LOWE: Exhibits A and B will be
- 8 accepted for this case.
- 9 (Exhibits A and B admitted.)
- 10 MS. LUCK: With that, I would ask that this case
- 11 be taken under advisement.
- 12 HEARING EXAMINER LOWE: Ms. Murphy, any
- 13 questions.
- 14 EXAMINER MURPHY: The current well is in the
- 15 Mesaverde and Dakota, and then we -- okay.
- MS. LUCK: It's a vertical well.
- 17 HEARING EXAMINER LOWE: Mr. Goetze?
- 18 EXAMINER GOETZE: Are we going to apply for
- 19 a downhole commingle?
- 20 MS. LUCK: I'm not sure about that, but --
- 21 EXAMINER GOETZE: You're looking at it.
- MS. LUCK: Mr. Carlson is actually here. I can
- 23 ask him.
- 24 EXAMINER GOETZE: Well, very good.
- 25 MS. LUCK: Yes, looks like we are going to be
