APPLICANT'S STATEMENT OF THE CASE

In **Case No. 21035**, Devon seeks an order pooling all uncommitted interests in the Wolfcamp formation (Brinninstool; Wolfcamp, West Pool [96689]) underlying a standard 792-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 21, 28, and irregular Section 33, Township 26 South, Range 34 East, NMPM, Lea County, New Mexico. Devon intends to initially dedicate this horizontal spacing unit to the following proposed wells:

- (1) The **Cobber 21-33 Fed Com #6H Well**, (2) The **Cobber 21-33 Fed Com #7H Well**, and (3) The **Cobber 21-33 Fed Com #13H Well**, each wells is to be drilled from a common surface hole location in the NW/4 NE/4 (Unit B) of Section 21 to bottom hole locations in the SW/4 NE/4 (Unit G) of Section 33; and
- (4) The **Cobber 21-33 Fed Com #8H Well**, and (5) The **Cobber 21-33 Fed Com #9H Well**, both wells are to be drilled from a common surface hole location in the NE/4 NE/4 (Unit A) of Section 21 to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 33.

The completed interval for the **Cobber 21-33 Fed Com #8H Well** will remain within 330 feet of the W/2 E/2 of Sections 21, 28, and 33 to allow inclusion of these proximity tracts in a standard horizontal well spacing unit comprised of the E/2 of Sections 21, 28, and 33.

In **Case No. 21036**, Devon seeks an order pooling all uncommitted interests in the Wolfcamp formation (Brinninstool; Wolfcamp, West [96689]) underlying a standard 792-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 21, 28, and irregular Section 33, Township 26 South, Range 34 East, NMPM, Lea County, New Mexico. Devon intends to dedicate the horizontal spacing unit to the following initial proposed wells:

- (1) The **Cobber 21-33 Fed Com #2H Well**, and (2) The **Cobber 21-33 Fed Com #10H Well**, both of which are to be drilled from a common surface hole location in the NW/4 NW/4 (Unit D) of Section 21 to bottom hole locations in the SW/4 NW/4 (Unit E) of Section 33; and

- (3) The **Cobber 21-33 Fed Com #3H Well**, and (4) The **Cobber 21-33 Fed Com #4H Well**, both of which are to be drilled from a common surface hole location in the NE/4 NW/4 (Unit C) of Section 21 to bottom hole locations in the SE/4 NW/4 (Unit F) of Section 33.

The completed interval for the **Cobber 21-33 Fed Com #10H Well** will remain within 330 feet of the E/2 W/2 of Sections 21, 28, and 33 to allow inclusion of these proximity tracts in a standard horizontal well spacing unit comprised of the W/2 of Sections 21, 28, and 33.

The applications in **Case Nos. 21035** and **21036** mistakenly indicated the well names as “Cobbler” due to a clerical error, which has been corrected above.
