**STATEMENT OF THE CASE**

**APPLICANT**

Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation in a horizontal spacing unit comprised of the S/2 of Section 15 and the S/2 of Section 16, Township 22 South, Range 27 East, NMPM. The unit will be dedicated to: (a) the Mighty Ducks 15/16 W0IL State Com. Well No. 2H, with a first take point in the NE/4SE/4 of 15 and a final take point in the NW/4SW/4 of Section 16; and (b) the Mighty Ducks 15/16 W0PM State Com. Well No. 1H, with a first take point in the SE/4SE/4 of 15 and a final take point in the SW/4SW/4 of Section 16. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.


