STATEMENT OF THE CASE

APPLICANT

Case No. 21058: Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation in a horizontal spacing unit comprised of the N/2N/2 of Section 25 and the N/2NE/4 of Section 26, Township 20 South, Range 28 East, NMPM. The unit will be dedicated to the Foxhole 25/26 W0AB Fed Com. Well No. 1H, with a first take point in the NE/4NE/4 of 25 and a final take point in the NW/4NE/4 of Section 26.

Case No. 21059: Mewbourne Oil Company seeks an order pooling all mineral interests in the Wolfcamp formation in a horizontal spacing unit comprised of the N/2S/2 of Section 25 and the N/2SE/4 of Section 26, Township 20 South, Range 28 East, NMPM. The unit will be dedicated to the Foxhole 25/26 W0IJ Fed Com. Well No. 1H, with a first take point in the NE/4SE/4 of 25 and a final take point in the NW/4SE/4 of Section 26

The unit will be dedicated to the Foxhole 25/26 W0PO Fed Com. Well No. 1H, with a first take point in the SE/4SE/4 of 25 and a final take point in the SW/4SE/4 of Section 26.

Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.




