STATEMENT OF THE CASE

Applicant in the above-styled cause seeks an order pooling all uncommitted interest owners in the Bone Spring formation underlying a standard 640-acre, more or less, horizontal spacing unit comprised of Lots 3-4, the S/2NW/4, and the SW/4 (W/2 equivalent) of irregular Section 4, Township 24 South, Range 32 East, and the W/2 of Section 33, Township 23 South, Range 32 East, Lea County, New Mexico. Applicant seeks to dedicate the above-referenced horizontal spacing unit to the following proposed wells:

- The **Mastiff Fed Com #204H**, the **Mastiff Fed Com #306H**, and the **Mastiff Fed Com #307H** wells to be drilled from surface hole locations in SE/4SW/4 (Unit N) of Section 4 to bottom hole locations in the NE/4NW/4 (Unit C) of Section 33,
- The **Mastiff Fed Com #205H**, the **Mastiff Fed Com #308H**, the **Mastiff Fed Com #309H**, the **Mastiff Fed Com #310H**, the **Mastiff Fed Com #505H**, the **Mastiff Fed Com #506H**, the **Mastiff Fed Com #507H** wells to be drilled from surface hole locations in SW/4SW/4 (Unit M) of Section 4 to bottom hole locations in the NW/4NW/4 (Unit D) of Section 33.

The completed intervals for the proposed **Mastiff Fed Com #308H** well will be within 330' of the quarter-quarter line separating the W/2W/2 and the E/2W/2 of Sections 4 and 33 to allow inclusion of this acreage into a standard 640-acre horizontal well spacing unit.

Also, to be considered will be the cost of drilling and completing the wells, the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of applicant as operator, and the imposition of 200% charge for risk involved in drilling and completing each well. Said area is located approximately 23 miles east of Loving, New Mexico.
