AWR seeks an order approving the Twin Sister SWD #1 well at a surface location 2170 feet from the North line and 183 feet from the West line of Section 29, Township 23 South, Range 34 East, NMPM, Lea County, New Mexico for the purpose

of operating a salt water disposal well. Applicant requests authorization to inject salt water into the into the Devonian-Silurian formation at a depth of 14,652'-16,318'. Applicant requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.
