**APPLICANT'S STATEMENT OF THE CASE**

Catena seeks an order: (1) pooling all uncommitted interests in the Bone Spring formation (Scharb Bone Spring; [Pool Code 55610]) underlying a standard 280-acre, more or less, horizontal spacing unit comprised of the W/2 NW/4 of Section 33, the W/2 W/2 of Section 28 and the SW/4

SW/4 of Section 21, Township 18 South, Range 35 East, NMPM, Lea County, New Mexico; and (2) dedicating this horizontal spacing unit to the proposed initial **Omega 183533 1H Well** to be horizontally drilled from a surface location in the NW/4 SW/4 (Unit L) of Section 33 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 21. The completed interval for the proposed well will comply with the statewide setback requirements for horizontal oil wells.




