VERIFIED STATEMENT OF ADRIANA SALGADO

Adriana Salgado, being duly sworn upon her oath, deposes and states:

- 1. I am a Landman for Mewbourne Oil Company ("Mewbourne") and have personal knowledge of the matters stated herein. I have worked as an associate landman for two years and a landman for a year. I hold a Bachelor of Arts Degree in Humanities from the University of Texas of the Permian Basin. I have 4 years of land work experience with Apache Corporation, prior to working at Mewbourne Oil Company. Collectively, I have 9 years of land work experience.
- 2. Pursuant to NMAC 19.15.4.12.A(1), the following information is submitted in support of the compulsory pooling application filed herein:
 - (a) The purpose of this application is to force pool working interest owners into the Wolfcamp formation horizontal spacing unit described below, and in wells to be drilled in the unit.
 - (b) No opposition is expected because the interest owners being pooled have been contacted regarding the proposed well but have failed or refused to voluntarily commit their interests to the well. All interest owners have been located.
 - (c) A plat outlining the unit being pooled is attached hereto as Exhibit 1. Mewbourne seeks an order approving a 240.00-acre horizontal spacing unit in the Wolfcamp formation comprised of the S2S2 of Section 25 and the S2SE of Section 26, Township 20 South, Range 28 East, NMPM, Eddy County, New Mexico. The unit will be dedicated to the Foxhole 25-26 W0PO Federal Com #1H. There are no depth severances in the Wolfcamp Formation.
 - (d) The parties being pooled and their interests are set forth in Exhibit 2. Their current and correct addresses are also set forth.



- (e) Exhibit 3 contains a summary of contacts with the interest owners, together with copies of the proposal letters sent to them, delivery receipts for each and copies of all email correspondence as listed.
- (f) In order to locate the interest owners, Mewbourne examined the county records, performed internet searches, checked telephone records, and searched pertinent computer searches.
- (g) Mewbourne has made a good faith effort to obtain the voluntary joinder of the working interest owners in the proposed well.
- (h) Mewbourne has the right to pool the overriding royalty owners in the well unit.
- (i) Exhibit 4 is the Authorization for Expenditure for the proposed well. The estimated cost of the well set forth therein is fair and reasonable, and is comparable to the costs of other wells of similar depth and length drilled in this area Eddy County.
- (j) Mewbourne requests overhead and administrative rates of \$8000/month for a drilling well and \$800/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this portion of Eddy County. Mewbourne requests that these rates be adjusted periodically as provided in the standard COPAS. Accounting Procedure.
- (k) Mewbourne requests that the maximum cost plus 200% risk charge be assessed against non-consenting working interest owners.
- (l) Applicant requests that it be designated operator of the well.
- (m) The attachments to this affidavit were prepared by me or under my supervision, or compiled from company business records.
- (n) The granting of this application is in the interests of conservation and the prevention of waste.



We anticipate drilling to an approximate total vertical depth of 9,175' and plan to continue drilling horizontally to the proposed bottom hole location at an approximate total measured depth of 16,995'.
- 4. Foxhole 25/26 W0AB Fed Com #1H located at a surface location 1400' FNL & 205' FEL of Section 25, with a bottom hole location 660' FNL & 2540' FEL of Section 26, of the above captioned lands. - 2. I am a geologist for Mewbourne Oil Company ("Mewbourne"), and I am familiar with the geological matters involved in this case. I have been qualified by the Division as an expert petroleum geologist.
- 3. The following geological plats are attached hereto:
- (a) Attachment A is a structure map of the Top of the Wolfcamp formation. It shows that structure dips gently to the east-southeast. It also shows a line of cross-section.
- (b) Attachment B is a gross sand isopach of the Wolfcamp Y SD, the test zone for the Foxhole 25-26 area. It shows that the sand across the well unit has a uniform thickness of approximately 60-80 feet.
- (c) Attachment C is a west-east cross section. The well logs on the cross-section give a representative sample of the Wolfcamp Sand formation in this area. The target zone for the well is the Wolfcamp Y Sand, and that zone is continuous across the well unit.
- 4. I conclude from the maps that:
- (a) The horizontal spacing unit is justified from a geologic standpoint.
- (b) Each quarter-quarter section in the unit will contribute more or less equally to production.
- (c) There is no faulting or other geologic impediment on the area which will affect the drilling of the subject well.






APPLICATION

Mewbourne Oil Company applies for an order pooling all mineral interests in the Wolfcamp formation underlying a horizontal spacing unit comprised of the S/2S/2 of Section 25 and the S/2SE/4 of Section 26, Township 20 South, Range 28 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

- 1. Applicant is an interest owner in the S/2S/2 of Section 25 and the S/2SE/4 of Section 26, and has the right to drill a well thereon.
- 2. Applicant proposes to drill the Foxhole 25/26 W0PO Fed Com. Well No. 1H to a depth sufficient to test the Wolfcamp formation, with a first take point in the SE/4SE/4 of 25 and a final take point in the SW/4SE/4 of Section 26.
