1 HEARING EXAMINER ORTH: Thank you. All right.
2 Let's begin with Case 21080, 81, 82 and 83. I assume they
3 will be consolidated for purposes of presentation since
4 these are compulsory pooling cases relating to wells
5 Dustbowl 1.

6 Appearances please.

7 MR. HOUGH: Good morning Lance Hough from the law
8 firm of Modrall Sperling on behalf of Apache Corporation. I
9 will pass out these packets here because I am allowed to
10 present these cases all together consolidated.

11 These are applications for compulsory pooling in
12 Lea County, specifically Sections 11 and 14, Township 19
13 South, Range 32 East, and to the extent necessary to
14 identify, the landman and geologist have not previously
15 testified before the Division, I have included their
16 qualifications as well as their resume, so if it's necessary
17 I can qualify to testify regarding their respective
18 expertise.

19 HEARING EXAMINER ORTH: Okay, thank you for
20 presenting those.

21 MR. HOUGH: As provided, behind Tab B is my
22 affidavit, which also included with that is the notice,
23 status of mailing and affidavit of publication demonstrating
24 that the cases are in compliance with the notice
25 requirements. So with that, unless the Division has any

1 questions or concerns, I just request that the affidavit and
2 corresponding exhibits be admitted and that the case be
3 taken under advisement.

4 (Exhibits offered.)

5 EXAMINER MURPHY: Timely notice?

6 MR. HOUGH: Yes. Notice was sent on February 10,
7 so I think 24 days ago, and then publication was published
8 February 12 which is 11 days.

9 EXAMINER MURPHY: And your checklist, they look
10 good. Thank you.

11 MR. HOUGH: Yes.

12 EXAMINER MURPHY: Sometimes the checklists have
13 been coming in and as they add more wells the font
14 decreases.

15 MR. HOUGH: I tried to avoid that unless I can,
16 but there are four separate checklists, one for each case.

17 EXAMINER MURPHY: How you avoid that, there is a
18 tool in Excel, and it's called print area and you extend the
19 print area. So, great, I have no further questions.

20 HEARING EXAMINER ORTH: Mr. Goetze?

21 EXAMINER GOETZE: No questions, thank you.

22 HEARING EXAMINER ORTH: Thank very much,
23 Mr. Hough. We will take it under advisement.
