- 2 USA, another request for amendment relating to well named
- 3 Salt Flat.
- 4 MS. BROGGI: Julia Broggi with Holland & Hart,
- 5 again with the applicant OXY USA, and again we are
- 6 requesting to present these consolidated cases by affidavit.
- 7 This case -- these two cases are very similar to
- 8 the last two cases I presented, where once again the
- 9 Division has already entered orders. Those orders are
- 10 attached as Exhibit C-1 and C-2.
- 11 Since those orders were entered, the applicant
- 12 has discovered some additional mineral interest owners that
- 13 need to be pooled under the terms of the same orders. We
