- 2 2113 the 21124, and 21125, applicant Chevron USA compulsory
- 3 pooling matters relating to a well named CB CAL 25.
- 4 MS. LUCK: Good morning again, Examiners.
- 5 Kaitlyn Luck with the Santa Fe office of Holland & Hart on
- 6 behalf of the applicant in these cases, Chevron USA Inc.
- 7 And before you I'm placing copies of the exhibits
- 8 because Chevron has requested that these cases be accepted
- 9 by affidavit, and it's my understanding it's the only other
- 10 party that has entered an appearance doesn't have an
- 11 objection to that.
- 12 HEARING EXAMINER ORTH: Other appearances? I
- 13 believe it was Hinkle Shanor.
- 14 MS. HARDY: Yes. Dana Hardy with the Santa Fe
- 15 office of Hinkle Shanor on behalf of Kaiser-Francis. I do
- 16 not object to the cases being presented based on the amended
- 17 prehearing statement which we had agreement with Chevron.
- 18 HEARING EXAMINER ORTH: Thank you.
- 19 MS. LUCK: Thank you. And that is also Chevron's
- 20 agreement as recited in Kaiser-Francis's prehearing
- 21 statement.
- Just to introduce you to this, they involve the
- 23 same acreage in the W/2 of Sections 25 and 36, Township 23
- 24 South, Range 28 East, in Eddy County, New Mexico.
- In Case 21113, Chevron is seeking to pool the

1 Wolfcamp formation in the Purple Sage Wolfcamp and dedicate

- 2 the entire W/2 of the section to a spacing unit that will
- 3 include three wells, the 401 through the 403 H wells.
- 4 And before you are the standard land and geology
- 5 exhibits for these three wells. Behind Exhibit C is the
- 6 land affidavit. Behind Exhibit D is the geologist
- 7 affidavit, and then behind Exhibit E is an affidavit from
- 8 our office reflecting that notice of this hearing was timely
- 9 provided to the interest owners to be pooled. Behind
- 10 Exhibit F is the notice of publication also reflecting that
- 11 the -- there was a publication of this hearing timely
- 12 before in the county where the wells are located.
- 13 And then turning to 21124 and 21125, these cases
- 14 are to pool the Bone Spring formation, and the first case
- 15 21124, that will be the E/2 of the W/2 of the two sections.
- 16 And that creates a Bone Spring spacing unit which is
- 17 dedicated to the 301-H and 303-H well. And then in 21125,
- 18 that's another Bone Spring spacing unit in the W/2 of the
- 19 W/2 which will be dedicated to a single well, the a 302-H
- 20 well.
- 21 Again in this packet are all the standard
- 22 exhibits for the two consolidated cases. The land exhibit
- 23 is Exhibit C, the geologist exhibit is Exhibit D, and then
- 24 behind Exhibits E and F are a notice affidavit and a notice
- 25 of publication reflecting notice this hearing was timely

- 1 provided.
- 2 HEARING EXAMINER ORTH: Okay. Questions, Ms.
- 3 Murphy?
- 4 EXAMINER MURPHY: Will they fill in the dedicated
- 5 acreage on the C-102?
- 6 MS. LUCK: It's my understanding what we are
- 7 submitting are just our drafts, so final C-102s will be
- 8 submitted to the Division having the correct acreage.
- 9 EXAMINER MURPHY: Okay. And this no proximity
- 10 tracts, standard completion, or standard locations.
- MS. LUCK: That's correct.
- 12 EXAMINER MURPHY: I have no further questions.
- HEARING EXAMINER ORTH: Mr. Goetze?
- 14 EXAMINER GOETZE: No questions. Thank you.
- 15 HEARING EXAMINER ORTH: Thank you Mr. Goetze.
