1 HEARING EXAMINER ORTH: So we will move to
2 matters 21140, 21141 and 21143. I take it that those will
3 be consolidated for presentation, although the numbers are
4 not continuous. The applicant is Chisholm Energy,
5 compulsory pooling matters all related to a well named Minis
6 1 Fed.

7 MS. LUCK: Good morning, Examiners. Kaitlyn Luck
8 on behalf of the applicant in this case Chisholm Energy, and
9 that is correct, the wells names are the Minis 1 Fed Com
10 wells.

11 And before you I'm passing the exhibit packets
12 for all three cases. I ask that these cases be considered
13 by affidavit, and so before you I have presented with you
14 exhibits for those cases. In case 21140 and 21141, Chisholm
15 is seeking to pool the Bone Spring formation in the W/2 of
16 the W/2 of Section 1, Township 21 South, Range 32 East, in
17 Lea County, and the E/2 of the W/2 of Section 1 in the same
18 township and range in Lea County. And these are to be
19 dedicated to spacing unit that are approximately 238.85
20 acres.

21 I have presented you with the standard exhibits.
22 Behind Exhibit C is the landman affidavit from Jacob
23 Daniels. Behind Exhibit D is the geologist affidavit from
24 Josh Kuhn. And then behind Exhibits E and F are proof that
25 notice was timely sent by our office to the parties to be

1 pooled.

2 And then behind Tab F is the notice of
3 publication that's reflecting that we also timely published
4 notice in the county where the wells are located. And then
5 in Case 21143, this is E/2 of the W/2 of that same section,
6 but this case pools the Wolfcamp formation in the E/2 of the
7 W/2.

8 So all of the same standard exhibits apply in
9 21143. And again our office provided timely notice of this
10 hearing by mail to the parties to be pooled, and we also
11 published timely notice which is behind Tab C and F.

12 HEARING EXAMINER ORTH: You have been busy. Any
13 questions, Ms. Murphy?

14 MS. LUCK: I will note on my checklist my well
15 names are small, and I can submit those revised wells on all
16 of the checklists.

17 EXAMINER MURPHY: No further questions.

18 HEARING EXAMINER ORTH: Thank you. The packets
19 are accepted and will be taken under advisement.

20 MS. LUCK: Thank you.
