**APPLICANT'S STATEMENT OF CASE**

In **Case No. 21152**, Ameredev seeks an order (1) pooling all uncommitted interest in the Wolfcamp formation (Jal; Wolfcamp, West Pool [Pool Code 33813]) underlying a standard 640.52-acre, more or less, spacing unit comprised of the E/2 W/2 and the W/2 E/2 of Sections 6 and 7, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico; and (2) dedicating the above-referenced horizontal spacing unit to the following proposed initial wells,

both of which will be horizontally drilled from a common surface location in the NE/4 NW/4 (Lot 3) of Section 6, to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 7: (1) **Par Three 25-36-06 Fed Com #103H Well** (API No. 30-025-46890); and (2) **Par Three 25-36-06 Fed Com #114H Well** (API No. 30-025-46945). The completed interval for the proposed **Par Three 25-36-06 Fed Com #114H Well** will be within 330' of the quarter-quarter line separating the E/2 W/2 and the W/2 E/2 of Sections 6 and 7 to allow inclusion of this acreage into a standard 640.52-acre horizontal well spacing unit.

In **Case No. 21153**, Ameredev seeks an order (1) pooling all uncommitted interest in the Wolfcamp formation (Jal; Wolfcamp, West Pool [Pool Code 33813]) underlying a standard 324.53-acre, more or less, spacing unit comprised of the W/2 W/2 of Sections 6 and 7, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico; and (2) dedicating the above-referenced horizontal spacing unit to the following proposed initial wells, both of which will be horizontally drilled from a common surface location in the SW/4 SW/4 (Lot 4) of Section 31, Township 24 South, Range 36 East, to a bottom hole location in the SW/4 SW/4 (Lot 4) of Section 7: (1) **Par Three 25-36-06 Fed Com #101H Well** (API No. 30-025-46944); and (2) **Par Three 25-36-06 Fed Com #112H Well** (API No. 30-025-46917). The completed interval of these wells will comply with statewide setbacks for oil wells.
