1 HEARING EXAMINER ORTH: Let's move then to 21020.

- 2 This is Chevron USA, a compulsory pooling matter for a well
- 3 named Solado Draw. Is there an appearance from Holland &
- 4 Hart?
- 5 MR. RANKIN: Good morning, Madam Examiner.
- 6 Appearing on behalf of the applicant in this case, Adam
- 7 Rankin with the law firm of Holland & Hart.
- 8 HEARING EXAMINER ORTH: Are there any other
- 9 appearances? Let me wait just a moment.
- 10 (No response.)
- 11 HEARING EXAMINER ORTH: Okay, thank you.
- 12 Mr. Rankin, go ahead.
- MR. RANKIN: (No response.)
- 14 HEARING EXAMINER ORTH: Mr. Rankin can you hear
- 15 me?
- 16 MR. RANKIN: I can hear you. I apologize.
- 17 Apparently my internet is not the strongest. Can you hear
- me okay?
- 19 HEARING EXAMINER ORTH: Now I can.
- 20 MR. RANKIN: Okay. Shall I proceed?
- 21 HEARING EXAMINER ORTH: Yes, please. Please go
- 22 ahead.
- 23 MR. RANKIN: Filed on Tuesday was a copy of the
- 24 affidavit of Katie Halley who is the landman for Chevron.
- 25 Her affidavit -- she has not previously testified before the

- 1 Division, so included with her affidavit as Exhibit A is a
- 2 copy of her resume reflecting that she is a graduate of the
- 3 Texas Tech University in December 2006 and also of Texas
- 4 Tech University School of Law in 2014. She has worked as a
- 5 landman since 2015, and I ask at this time that she be
- 6 accepted as an expert in petroleum land matters.
- 7 HEARING EXAMINER ORTH: All right. I will so
- 8 accept her. Thank you.
- 9 MR. RANKIN: Madam Examiner, in Exhibit 32 is a
- 10 copy of Ms. Halley's affidavit. In it she reviews efforts
- 11 and steps she has taken to provide notice of this
- 12 application and of this hearing.
- 13 Exhibit B to her affidavit is an overview locator
- 14 map identifying the general location of Chevron's proposed
- 15 pilot project injection wells within the project area,
- 16 located in the Township 26 South, Range 33 East in Lea
- 17 County.
- 18 Exhibit C attached to her affidavit is a zoomed
- 19 in map showing the half mile area of review around each of
- 20 the proposed project injection wells. In green is the oval
- 21 depicting the area of review around the Salado 2H, and in
- 22 red is the oval depicting the area of review around the
- 23 Salado Draw 5-H well.
- Also within the map, each of the separately-owned
- 25 tracts is identified by number and is also color coded.

1 The following the pages in Exhibit C reflect the

- 2 interest owners, affected parties who were entitled to
- 3 notice. Parties entitled to notice are identified based on
- 4 the determination of final and land interests in the county
- 5 records, and also review of New Mexico oil and gas, OCD
- 6 records and BLM records as operators.
- 7 She testifies she has undertaken a good faith
- 8 effort to identify and locate the correct parties and valid
- 9 addresses of all parties entitled to notice within the half
- 10 mile area of review for each of the proposed injection
- 11 wells, including interest owners in each case.
- 12 Exhibit 33 is a copy of the affidavit prepared by
- 13 me and my office reflecting that we have sent notice to each
- of the parties identified to us by Chevron as entitled to
- 15 notice, including the surface owner, in each case that's the
- 16 BLM.
- 17 Next Exhibit 34 is a copy of the notice of
- 18 publication -- affidavit of publication reflecting that we
- 19 have published notice identifying each of the affected
- 20 parties entitled to notice by name including the surface
- 21 owner for each of the wells.
- 22 If there are no questions, Madam Examiner, at
- 23 this time I would ask that Exhibits 32 through 34 be
- 24 accepted into the record.
- 25 HEARING EXAMINER ORTH: Yes. Your exhibits are

- 1 accepted. Let me ask Mr. Coss if he has any questions at
- 2 this time.
- 3 EXAMINER COSS: No, I don't have any questions,
- 4 but I thank Mr. Rankin for getting on this docket and
- 5 completing as he mentioned here, the land person. I wanted
- 6 to let him know that we are working on the order, but that
- 7 we probably will request that CBLs be ran of the well that
- 8 hasn't had a CBL submitted. So just a heads up for you and
- 9 Chevron, we would like to start working on that. It will be
- 10 a hurdle that will be own overcome or injection --
- 11 HEARING EXAMINER ORTH: Okay. Thank you, Mr.
- 12 Coss. Mr. Lowe, do you have any --
- 13 EXAMINER LOWE: I don't have any questions.
- 14 Thank you.
- 15 HEARING EXAMINER ORTH: All right. Thank you.
- 16 Thank you very much Mr. Rankin. Your packet is accepted and
- 17 will be taken under advisement.
