1 HEARING EXAMINER ORTH: Moving then to matters
2 21148, 21149 -- let me just call 21150 and 21151. The
3 notice on with 21148 and 49, there are no other appearances.
4 For 21150 and 51, we do have another appearance.

5 Does it nevertheless make sense to discuss all
6 four of them at once because Matador Production is the
7 applicant and the well is Uncle Ches.

8 MR. FELDEWERT: Madam Examiner, this is Michael
9 Feldewert appearing on behalf of the applicant in these four
10 cases, and yes, we would ask that they be consolidated with
11 the caveat that, as you pointed out, ConocoPhillips has
12 entered an appearance in two of the cases, 21150 and 21151,
13 which essentially involves what I would call the E/2
14 acreage.

15 HEARING EXAMINER ORTH: All right. Who is here,
16 please, for ConocoPhillips.

17 MR. SAVAGE: Darin Savage with Abadie & Schill on
18 behalf of ConocoPhillips. No objection to the consolidation
19 of the hearing, and no objection to proceeding by affidavit.

20 HEARING EXAMINER ORTH: All right. Thank you
21 very much, Mr. Savage, for that. Mr. Feldewert?

22 MR. FELDEWERT: Certainly. We filed with the
23 Division a consolidated package of exhibits for these four
24 cases, and as you page through them you will see that it has
25 a cover sheet, which is table of contents. You will then

1 find a compulsory pooling checklist for each case in the
2 order in which the cases are numbered.

3 Behind that you will find the applications that
4 were filed for pooling in each of these four cases, followed
5 by an Exhibit A from the landman who is testifying in this
6 case by affidavit and who has previously testified before
7 the Division, and that is provided as Exhibit A.

8 And what you will see is that we seek to pool the
9 Bone Spring formation and create four separate stand-up,
10 two-mile horizontal spacing units, 320 acres each, in
11 Sections 16 and 21, in Township 20 South, Range 35 East.

12 Mr. Prior's affidavit, landman Exhibit A,
13 provides all the information that the Division, the Division
14 has indicated it desires for these types of pooling cases.

15 Exhibit B in the package is the affidavit from
16 the geologist in this case, Mr. James Andrew Juett, who
17 likewise has testified previously before this Division as an
18 expert in geology. And it contains not only the location
19 map, but a structure map, and any cross section which is
20 addressed in his affidavit.

21 Exhibit C is the notice affidavit for all four of
22 these cases. You will see that we are notifying not only
23 working interest owners, but there is some overriding
24 royalty interest owners that required notice and pooling.

25 The records reflect that some of those mineral

1 owners received the notice, but some of them, particularly
2 some trusts, the notice was returned, and as a result, we
3 filed as an Exhibit D an affidavit of publication for each
4 of these four cases notifying the parties of the hearing in
5 this matter by way of local means.

6 We ask that Exhibits A, B, C, D be admitted into
7 the record in these consolidated cases.

8 HEARING EXAMINER ORTH: All right. Any
9 objections, Mr. Savage.

10 MR. SAVAGE: No objection.

11 HEARING EXAMINER ORTH: Thank you. A, B, C, D
12 are admitted.)

13 MR. FELDEWERT: That concludes my presentation.
14 I would ask it be taken under advisement unless any
15 examiners have questions.

16 HEARING EXAMINER ORTH: Thank you. Mr. Coss, do
17 you have questions?

18 EXAMINER COSS: I do not have any questions at
19 this time, and I believe Mr. Lowe stepped away, so that's --

20 HEARING EXAMINER ORTH: Yes, thank you. And,
21 Mr. Savage, do you have anything to add?

22 MR. SAVAGE: No questions. Thank you.

23 HEARING EXAMINER ORTH: All right. Thank you.
24 Thank you, Mr. Feldewert, your package is accepted and will
25 be taken under advisement.
