Page 3 1 HEARING EXAMINER ORTH: So, Mr. Bruce, our last 2 five cases, 21163, 64, 65, 66 and 67. Let me ask, I noticed that although they are numbered consecutively that way, four 3 4 of them relate to a well named Bourbon, and one of them 5 relates to a well named Pavo Frio. If you would you please 6 address those to make sense. 7 MR. BRUCE: Yeah. It was just the order the 8 applications were filed in when I did that over a month ago. 9 What we can do is take 21164, because that is separate from 10 the other four. The other four can be combined. HEARING EXAMINER ORTH: That's what I thought. 11 12 And there are no other appearances in 21164 at this moment, 13 Mewbourne Oil, the well is Pavo Frio. You are appearing for 14 Mewbourne Oil. Let me pause just a moment to ask if there 15 is any other appearance at this time. (No response.) 16 17 HEARING EXAMINER ORTH: No? All right. If you 18 would proceed on 21164. MR. BRUCE: Yes. That case involves pooling of 19 the Bone Spring Formation in N/2 NE of Section 29 and N/220 N/2 of Section 28, in 18 South, 29 East for a mile and a 21 half lateral for the Pavo Frio at 29/28 B3BA Fed Com well 22 Number 1H. 23 24 The exhibit package, six exhibits, the 25 application and proposed ad, the land affidavit, the geology

affidavit, the affidavit of notice and the affidavit of
publication. And publication, I did that just as a back-up,
but notice is complete.

I actually mailed out notice to five people. If you look at the landman's affidavit, the only person being pooled at this time is a woman named Donna Blevin, B-l-e-v-i-n, and she may be deceased, apparently is, but there is no probate.

9 So Mewbourne has been dealing with trying to get 10 more information on this estate for its wells in this area 11 for at this point about a year and a half and has never 12 located her, so notice was given to her last known address 13 and somebody, somebody picked it up, but also notice was 14 published against her.

And of course the pooling checklist is included, the application package is complete and I would ask that Exhibits 1 through 6 be admitted into the record.

18 HEARING EXAMINER ORTH: Exhibits 1 through 6 are 19 admitted.

20 Mr. Coss do you have any questions of Mr. Bruce 21 relating to 21164.
