STATEMENT OF THE CASE

Mewbourne seeks an order pooling all uncommitted mineral interests in the Bone Spring formation in a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4 of Section 6 and the S/2 N/2 of Section 5, Township 18 South, Range 32 East in Lea County, New Mexico. The horizontal spacing unit will be dedicated to the Winterfell 6/5 B2GH Fed Com #1H well, which will be horizontally drilled from a surface location in Unit G in Section 6 to a bottom hole location in Unit H in Section 5. The completed interval for the well will be orthodox. Also to be considered will be the costs of drilling and completing the well and the allocation of the costs, the designation of Mewbourne Oil Company as the operator of the well, and a 200% charge for the risk involved in drilling and completing the well.

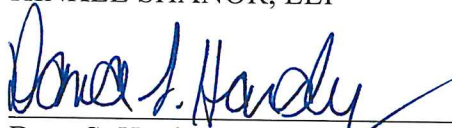

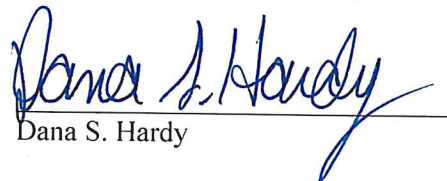
