**STATEMENT OF THE CASE**

Applicant in the above styled cause seeks an order pooling all uncommitted interests in the Wolfbone formation, WC-025 G-09 S243532M;WOLFBONE (Pool code 98098), underlying a standard 641.01-acre, more or less, horizontal spacing unit comprised of Lots 3 & 4, S/2NW/4, SW/4 (W/2) of Section 5 & W/2 of Section 8, Township 25 South, Range 35 East, NMPM, Lea County, New Mexico. Said spacing unit shall be dedicated to the following well(s):

- The **Deerstalker Federal Com 606H** well to be horizontally drilled from a surface hole location in Lot 4 of Section 5 to a bottom hole location in the SE/4SW/4 (Unit N) of Section 8,
- The **Deerstalker Federal Com 703H** well to be horizontally drilled from a surface hole location in Lot 3 of Section 5 to a bottom hole location in the SE/4SW/4 (Unit N) of Section 8, and
- The **Deerstalker Federal Com 705H** well to be horizontally drilled from a surface hole location in Lot 4 of Section 5 to a bottom hole location in the SW/4SW/4 (Unit M) of Section 8.

The completed interval for the proposed **Deerstalker Federal Com 606H** will be within 330' of the line separating the W/2W/2 and E/2W/2 of Sections 5 and 8, which allows inclusion of this acreage into a standard 641.01-acre, more or less, horizontal spacing unit.

Also to be considered will be the timing of the drilling and completing of said wells, the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of COG Operating LLC as operator of the wells, and the imposition of 200% charge for risk involved in drilling and completing said wells. Said area is located approximately 11 miles northwest of Jal, New Mexico.
