1 HEARING EXAMINER ORTH: Move to the next matter.

- 2 The first one is 21176, compulsory pooling matter, applicant
- 3 Kaiser-Francis, well name Brantley Fee 2419.
- 4 Is Mr. Bruce on the phone?
- 5 MR. BRUCE: Yes, I am, Madam Examiner. And I
- 6 would ask that these three cases be presented right at the
- 7 end with the final Kaiser-Francis case. They are all
- 8 interrelated, and they all will be presented by affidavit.
- 9 And Holland & Hart can confirm, but MRC Permian has agreed
- 10 that certain of these cases can be presented by affidavit.
- 11 HEARING EXAMINER ORTH: All right. Thank you.
- 12 We will move these three down. I see Mr. Feldewert turned
- on his video. Do you have something to add?
- MR. FELDEWERT: No, I will wait until we move
- 15 them towards the end.
- 16 (Pause in proceeding.)
- 17 HEARING EXAMINER ORTH: Let's take the last four
- 18 matters then. This is 21176, 21177, 21178 and 21179. They
- 19 are all compulsory pooling matters related to the wells
- 20 Brantley and Mosaic.
- 21 Mr. Bruce, are you here for the applicant?
- MR. BRUCE: Yes, I am.
- 23 HEARING EXAMINER ORTH: All right. Mr.
- 24 Feldewert.
- MR. FELDEWERT: Madam Examiner, Michael Feldewert

- 1 with the Santa Fe office of Holland & Hart. We are
- 2 appearing on behalf of MRC Permian LLC Company in just three
- 3 of these four cases, case 21177 through 21179, which involve
- 4 the Mosaic wells.
- 5 HEARING EXAMINER ORTH: All right. Thank you.
- 6 Are there any other appearances in these matters?
- 7 (No response.)
- 8 HEARING EXAMINER ORTH: Okay. Mr. Bruce, will we
- 9 hear a presentation by affidavit from the parties --
- MR. BRUCE: Yes.
- 11 HEARING EXAMINER ORTH: Or just --
- MR. BRUCE: No, no, they are being presented by
- 13 affidavit.
- 14 HEARING EXAMINER ORTH: Okay. Mr. Feldewert, do
- 15 you have any objection?
- 16 MR. FELDEWERT: We have no objection to the case
- 17 proceeding by affidavit.
- 18 HEARING EXAMINER ORTH: Thank you very much.
- 19 Please go ahead, Mr. Bruce.
- 20 MR. BRUCE: Okay. These four cases involve --
- 21 collectively involve all of Section 24 of 23 South, 28 East,
- 22 and Section 19 -- adjoining Section 19 of 23 South, 29 East.
- 23 The first case is for the Brantley Fee 2H well. The
- 24 remaining are the Mosaic wells.
- 25 Each of the exhibit packages is pretty similar.

1 The witnesses are the same, Michael Maxey, the landman, and

- 2 Lee Lindman, the geologist. Both have been qualified and
- 3 testified before the Division. And each package contains an
- 4 application and proposed ad, the landman's affidavit and the
- 5 geologist affidavit. Also contained is an affidavit of
- 6 mailed notice.
- 7 These cases were not advertised in the newspaper
- 8 because there were no unlocatable people. And then each
- 9 package contains a checklist, pooling checklist.
- 10 As to the first case, 21176, I noticed this
- 11 morning in looking at it, that Exhibit 5, the pooling
- 12 checklist, has a typo at the top. My dyslexia kicked in and
- 13 it should say 21176 and it says 21167, so I would ask
- 14 permission to correct that and e-mail that to the Division.
- 15 HEARING EXAMINER ORTH: If you would, please.
- 16 MR. BRUCE: And then those -- the Brantley well
- 17 is a Wolfcamp well in the Purple Sage Wolfcamp gas pool in
- 18 the S/2 of the two sections I mentioned.
- 19 The remaining three cases, 21177 is for a Bone
- 20 Spring well, a second Bone Spring well, as is 21178. The
- 21 first one is in the N/2 N/2 of the section, and the second
- 22 is in the S/2 N/2 of the sections.
- 23 In case 21179 is for several Wolfcamp wells,
- 24 again Purple Sage Wolfcamp gas pool with covering the N/2 of
- 25 the two sections I previously mentioned. As I said, in all

- 1 four cases the compilation of data is the same, land,
- 2 geology, affidavit of the notice and pooling. And everyone
- 3 did receive notice.
- 4 And with that I would move the admission of
- 5 Exhibits 1 through 5 in each case.
- 6 HEARING EXAMINER ORTH: All right. Thank you.
- 7 Mr. Feldewert, do you have any questions or -- to the
- 8 exhibits.
- 9 MR. FELDEWERT: No objections and no questions.
- 10 HEARING EXAMINER ORTH: Thank you. Exhibits 1
- 11 through 5 are admitted.
- Mr. Coss, do you have questions of Mr. Bruce?
- 13 EXAMINER COSS: No, no, I don't have any
- 14 questions at this time. Thank you.
- 15 HEARING EXAMINER ORTH: Thank you. Mr. Cox, do
- 16 you have questions of Mr. Bruce.
- 17 EXAMINER COX: No questions. Thanks for noticing
- 18 that typo. If you could get that in to us as soon as
- 19 possible, we appreciate it.
- MR. BRUCE: I will do it this morning.
- 21 HEARING EXAMINER ORTH: All right. Thank you.
- 22 Thank you very much, Mr. Bruce. The exhibits are admitted
- 23 and the packet is accepted and will be taken under
- 24 advisement.
- MR. BRUCE: Thank you.
