1 HEARING EXAMINER ORTH: We will move then to

- 2 matter 21182. This is also Devon Energy to the -- case.
- 3 Mr. Feldewert, is this you again?
- 4 MR. FELDEWERT: No. I think my colleague,
- 5 Kaitlyn Luck, will be --
- 6 HEARING EXAMINER ORTH: All right. Ms. Luck?
- 7 MS. LUCK: Good morning, Madam Examiner, Kaitlyn
- 8 Luck from the Santa Fe office of Holland & Hart for
- 9 applicant Devon Energy Production Company LP. And in this
- 10 case it's our understanding there are no other entries of
- 11 appearance or opposition to this case proceeding by
- 12 affidavit, and so we submitted the exhibits to the Division
- 13 that are the affidavits on April 28. And so with that I
- 14 would ask to present this case by affidavit.
- 15 HEARING EXAMINER ORTH: All right. Let me take a
- 16 moment and ask if there are any other appearances?
- 17 (No response.)
- 18 HEARING EXAMINER ORTH: Hearing none, please go
- 19 ahead.
- 20 MS. LUCK: Thank you. So in this case Devon
- 21 Energy has applied for approval of two 1280-acre off-
- 22 centered spacing units, that would be one in the Bone Spring
- 23 and one in the Wolfcamp formation.
- 24 And both of these spacing units are subject to
- 25 the proposed -- BLM. The 1280-acre spacing unit in these

- 1 two cases are located in Sections 22 and 27, Township 23
- 2 South, Range 29 East, in Eddy County, New Mexico.
- In the exhibit packets that were provided to the
- 4 Division on April 28, there is the affidavit of the landman
- 5 in this case, Verl Brown. He provides a land plat of the
- 6 non-standard unit. And then he also provides copies of the
- 7 Bone Spring and Wolfcamp proposed unitization agreement.
- 8 He also provides exhibits, a plat of the Bone
- 9 Spring development plan C-102 for each of the wells, and
- 10 then he provides the Wolfcamp development plan with a C-102
- 11 for each of those wells. He also provides the Bone Spring
- 12 and Wolfcamp pools involved in this application. The Bone
- 13 Spring pools are the -- Bone Spring Pool Code 96721, and
- 14 Laguna Bone Spring Pool Code 96857, and in the Wolfcamp
- 15 unit, it only involves the Purple Sage Wolfcamp Gas Pool
- 16 Code 98220.
- 17 Finally, Mr. Brown provides a plat of the parties
- 18 who were provided notice of this hearing, and his affidavit
- 19 is attached to the back, and proper notice was provided as
- 20 required by the rules.
- 21 As Exhibit B, Devon provides the exhibit, an
- 22 affidavit of Miranda Childress who is the geologist in this
- 23 case. She provides a structure map and cross section map
- 24 for both the Bone Spring and Wolfcamp formations. And she
- 25 also provides a diagram of the development in the Bone

- 1 Spring and Wolfcamp formations in these two sections.
- 2 Her affidavit provides that in her opinion the
- 3 proposed stand-up orientation of these wells is appropriate
- 4 for the development of the Bone Spring and Wolfcamp
- 5 formations in this area.
- 6 And then finally as Exhibit B is the affidavit of
- 7 the Lauren Sykes who is the engineer in this case. She has
- 8 not previously testified before the Division, so she
- 9 provides her experience, education, and her credentials, and
- 10 we request to be admitted as an expert petroleum engineer in
- 11 this case.
- 12 And her affidavit goes on to explain that the
- 13 surface facilities that should be implemented by approval of
- 14 the two -- rather than this development going forward as
- 15 standard horizontal spacing units. Her affidavit explains
- 16 that with the proposed non-standard units, there only has to
- 17 be one surface facility for the Bone Spring unit and one for
- 18 the Wolf Camp spacing unit. And that would be six acres per
- 19 -- she finally provides the net that explains the cost of
- 20 the horizontal from seven facilities as required by the --
- 21 unit.
- One actual point that I wanted to mention, with
- 23 respect to these units is that they were previously approved
- 24 for pooling in order numbers R-20957, R-20958, R-20959,
- 25 R-20960 and R-20961. And in those cases they had applied

1 for a standard pooling unit, but by this application Devon

- 2 is withdrawing those pooling orders and requests for
- 3 these two non-standard units to be approved, which is a --
- 4 requested, but the spacing unit will line up with the
- 5 proposed unitization unit.
- 6 And then finally as Exhibit E and F are the
- 7 notice of -- sorry -- D and E are the notice letters and the
- 8 notice affidavit along with the publication reflecting that
- 9 the hearing was timely provided to the parties as required
- 10 by the Division's rules. And Devon also provides a copy of
- 11 the application with that. So I would move the admission of
- 12 Exhibits A through F in this case.
- 13 And if there are any questions --
- 14 HEARING EXAMINER ORTH: Thank you, Ms. Luck.
- 15 Exhibit A through F are accepted. Ms. Murphy, do you have
- 16 any questions of Ms. Luck?
- 17 EXAMINER MURPHY: I don't. Thank you.
- 18 HEARING EXAMINER ORTH: Mr. Coss, do you have
- 19 questions?
- 20 EXAMINER COSS: Good morning, Ms. Luck. How are
- 21 you today? So -- and thanks for the presentation. The
- 22 question I have as a matter of clarification, you are at the
- 23 end that these non-standard spacing units are going to be in
- 24 place of compulsory pooling requirements, or what might --
- 25 maybe I didn't -- go ahead.

1 MS. LUCK: Devon had previously applied for

- 2 pooling for the same acreage, and those are the orders I had
- 3 listed off which are 20955 through 20961. And by filing
- 4 this application Devon is withdrawing or requests in those
- 5 cases for standard spacing units and instead is seeking
- 6 these two non-standard spacing units rather than those
- 7 standard units that were approved --
- 8 EXAMINER COSS: Okay, thank you. And just for my
- 9 edification, what was the cause of them going to a
- 10 non-standard from standard?
- 11 MS. LUCK: Yes. That exhibit, Exhibit A, so the
- 12 BLM only approved the unitization agreement that line up
- 13 with the spacing requirements, and so in this case, in order
- 14 for the BLM to approve the unitization agreement for the
- 15 Bone Spring and the Wolfcamp comprising of these two entire
- 16 sections, then Devon has to get a non-standard unit approval
- 17 that matches those.
- 18 EXAMINER COSS: Okay. Well, thank you for that
- 19 clarification, Kaitlyn, and withdraw the question.
- 20 HEARING EXAMINER ORTH: Thank you, Mr. Coss. Ms.
- 21 Luck, the packet is admitted and the case will be taken
- 22 under advisement. I see someone else wanting to join us?
- 23 (Exhibits admitted.)
