**MOTION TO APPEAR PRO HAC VICE**

Pursuant to § 24-106 NMRA and the Rules and Regulations of the New Mexico Oil Conservation Division (“Division”), Jillian Fulcher, attorney with Beatty & Wozniak, P.C., files this motion seeking permission from the Division to appear *pro hac vice* on behalf of Chevron U.S.A. Inc. (“Chevron” or “Applicant”) in the above-referenced cases which will be consolidated for hearing. In support of this motion, the movant states and alleges as follows:

1. Pursuant to § 24-106.A., upon filing a registration certificate together with payment of the relevant fees with the State Bar of New Mexico, an attorney authorized to practice law before the highest court of record in any state or country (“nonadmitted attorney”) may perform legal services on behalf of a client or party, even though the attorney is not licensed to practice law in New Mexico, so long as the nonadmitted attorney appears in association with an active member in good standing with the State Bar of New Mexico.

2. A registration certificate has been filed and accepted by the State Bar of New Mexico, certifying that: (1) Ms. Fulcher is a licensed attorney in good standing with the State of Colorado; (2) Ms. Fulcher has not been disciplined, suspended, or disbarred in any jurisdiction; (3) Ms. Fulcher has not had a *pro hac vice* admission revoked in any jurisdiction; (4) Ms. Fulcher will comply with the applicable statutes, laws, and procedural rules of the state of New

Mexico; and (5) Ms. Fulcher will comply with the Rules of Professional Conduct, the Rules Governing Discipline, the Rules Governing the New Mexico Bar, and the rules governing civil, criminal, and appellate procedure approved by the Supreme Court, and will submit to the jurisdiction of the New Mexico courts and the Disciplinary Board with respect to acts or omissions occurring during the attorney's admission under 24-106 NMRA and with respect to the requirements of Rules 1-089.1, 2-107, 3-107, 5-108, 12-302, 16-104(C) and 26-106 NMRA. The registration certificate also included payment of the relevant fees to the State Bar of New Mexico. A copy of the registration certificate is attached hereto as Exhibit A.

3. Candace Callahan (Registration No. 5838) is a member in good standing with the State Bar of New Mexico.


4. Mr. Fulcher will appear with Ms. Callahan in the above-referenced cases, and all matters connected thereto.


