## ORDER SETTING OUT BRIEFING SCHEDULE FOR MOTIONS

This Order follows several recent developments in this case:

- a. The issuance of Order No. R-20996-A on May 7, 2020;
- b. The filing of a Motion to Vacate or Stay Order No. R-20996-A on June 5, 2020, by Sugar Creek Resources, LLC (Sugar Creek);
- c. An Application for De Novo Hearing filed on June 5, 2020 by MRC Permian Company (MRC);
- d. An Application for Hearing De Novo filed on June 11, 2020 by Sugar Creek; and
- e. A Motion to Strike and Request for Extension of Time filed by Applicant Marathon Oil Permian LLC (Marathon) on June 15, 2020.

In Order No. R-20996-A, OCD retained jurisdiction for the entry of such orders as may be deemed necessary. Moreover, notwithstanding the applications for *de novo* hearing before the Commission, Section 19.15.4.23.B NMAC authorizes the Division to consider motions to stay.

Section 19.15.4.16.C NMAC requires that an interested party have a reasonable opportunity to respond to a motion, and the Director or Division Examiner may conduct a motion hearing. The adjudicatory rules do not set out timelines for responses or replies to motions, necessitating this order.

- 1. Marathon shall file a response to Sugar Creek's Motion to Vacate or Stay by 5 p.m. on June 30, 2020. MRC is invited to file a response to the Motion by the same deadline.
- 2. Sugar Creek shall file a reply to Marathon's response by 5 p.m. July 7, 2020.
- 3. Sugar Creek shall file a response to Marathon's Motion to Strike by 5 p.m. on June 30, 2020. MRC is invited to file a response to the Motion by the same deadline.

- 4. Marathon shall file a reply to Sugar Creek's response by 5 p.m. on July 7, 2020.
- 5. The Hearing Examiner will accept argument and evidence on these motions at a hearing to be held the end of OCD's regularly scheduled docket on July 9, 2020.
