This is more of my pre hearing statement, my name is Sandra Dene Wilbur: Evidence of false statements by Attorney James Bruce.

AND MINERAL LEASE 39841, BOOK 307, PAGE 409 .( See attachment ) My Uncle either purchased it out right or as his part of a division of sections previously joined ownership.

These two persons, Patricia Dugger and Mancil Sanders have a relationship or maybe step-relationship , the ladder is most likely, to Ben.L. Fonville and/or Maurine Fonville . Ben Fonville may have a relation ship to my uncle James A Skinner wife , Ella May Fonville Skinner, who passed away April 11, 1966. They had no children and my uncle never remarried.

This is totally unacceptable to me and it should also be to the Courts Of New Mexico. My

sister and I have with the help of our attorneys have been for months activity seeking leasing our section 19 for just leasing and royalties. We have for months been working on getting all our legal rights in order. Even with the added burden of Covid 19, with strict stay home orders from of our Governor Roy Cooper of North Carolina, our state has been hit hard in this pandemic.

I have no knowledge of Mr. Bruce nor his client Tap Rock Resources prior to Mr. Bruce letter I received July 9,2020, telling me and the court he is taking over my use of my rightful ownership of Section 19. Claims he made in APPLICATION CASE NO. 21340 are so unbelievable.
