**UNOPPOSED MOTION TO

1. In Case Nos. 21347 and 21348, Catena Resources Operating, LLC seeks an order pooling all uncommitted interests in the Wolfcamp and Bone Spring formations underlying a standard 640-acre, more or less, horizontal spacing units comprised of the E/2 of Section 36, Township 18 South, Range 34 East, and the E/2 of Section 1, Township 19 South, Range 34 East, NMPM, Lea County, New Mexico.

2. In Case Nos. 21349 and 21350, Catena Resources Operating, LLC seeks an order pooling all uncommitted interests in the Wolfcamp and Bone Spring formations underlying a standard 640-acre, more or less, horizontal spacing units comprised of the W/2 of Section 36, Township 18 South, Range 34 East, and the W/2 of Section 1, Township 19 South, Range 34 East, NMPM, Lea County, New Mexico.

3. Case Nos. 21347 – 21350 are currently set for hearing, under a pre-trial order, on September 24, 2020.

4. The parties of record have agreed to continue the subject cases to the October 22, 2020 Examiner Hearing Docket.

5. COG will file the continuance motions separately.

Wherefore, COG requests that the current pre-trial order be vacated, and the subject cases be continued to the October 22, 2020 Examiner Hearing Docket.
