The unit will be dedicated to the Pony Express Fed. Com. Well Nos. 503H and 602H, with first take points in the NE/4NW/4 of Section 16 and last take points in the SE/4SW/4 of Section 21.

Case No. 21504: Applicant seeks an order pooling all mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the E/2W/2 of Section 16 and the E/2W/2 of Section 21, Township 20 South, Range 33 East, NMPM. The unit will be dedicated to the Pony Express Fed. Com. Well No. 702H, with a first take point in the NE/4NW/4 of Section 16 and a last take point in the SE/4SW/4 of Section 21.

Also to be considered in each case will be the cost of drilling, completing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, and equipping the wells.
