EOG Resources, Inc. ("EOG") has majority operating rights and is the designated operator under an operating agreement of the captioned oil and gas lease. In pursuit of developing this oil and gas leasehold, we are submitting APDs for our Igor 33 Federal wells decribed on the attached Exhibit "A". EOG received Mastiff Fed Com well proposals ("Mastiff wells") from COG Operating LLC ("COG") that propose to include NMNM-077063 (the "Subject Lease"). These wells are identified on Exhibit "B" and as proposed, the Mastiff well plan interfers with EOG's Igor 33 Federal development plan for the Subject Lease.

EOG **objects** to the inclusion of the Subject Lease in COG's Mastiff well development for the following reasons; (1) COG has no ownership interest in the Subject Lease, and (2) Including the W/2 of Section 33 of the Subject Lease in COG's development plan would obstruct development of the W/2 of Section 28, which is also covered by the captioned lease is being excluded. EOG's 2 mile development plan for the Igor 33 Federal wells includes both the W/2 of Section 28 and 33 ensuring full lease development with extended laterals and without communitization. We protest the placement of the Mastiff wells on our leasehold and request BLM to deny any APD to COG (or other operater) for the Mastiff wells that include the Subject Lease.
