EOG Resources, Inc. ("EOG") has received and reviewed the COG Operating LLC ("COG") proposals to drill 17 wells identified in Exhibit "A" attached herein. It is EOG's understanding that the proposed wells have surface locations set along the lease line in the SE/4 of Section 9, T24S, R32E on EOG Lease NMNM-55993. This proposal conflicts with EOG's 1.5 mile development plans for the SE/4 of Section 9, T24S, R32E. A breakdown of EOG's planned wells targeting both the Bone Spring formation and the Wolfcamp formation are included in Exhibit "B" attached herein. Therefore, EOG declines to participate in your plans and requests that you exclude lease NMNM-55953 from your development plans.
