1 HEARING OFFICER ORTH: Good morning. This is

- 2 Felicia Orth. I'm the hearing officer appointed by the
- 3 director of the Oil Conservation Division to conduct the
- 4 hearing this morning in matters 21390 and 21391. Marlene,
- 5 how is my sound?
- 6 MS. SALVIDREZ: You sound great.
- 7 HEARING OFFICER ORTH: Thank you. We had also
- 8 noticed up matters 21447 through 21454. These were
- 9 competing applications by Matador Production, but those
- 10 matters have been dismissed.
- 11 As I understand it, we will not be having a full-
- 12 blown evidentiary hearing today, that the matters will
- 13 proceed by affidavit as a result of negotiations among the
- 14 parties.
- There are six of us on the call, there is no one
- 16 in the waiting room, but I will keep an eye on it. Ms.
- 17 Hardy, if you would, please, provide your appearance.
- 18 MS. HARDY: Yes. Good morning, Madam Examiner,
- 19 Dana Hardy with the Santa Fe office of Hinkle Shanor on
- 20 behalf of Mewbourne Oil Company.
- 21 HEARING OFFICER ORTH: Thank you. And I see Ms.
- 22 Luck. Ms. Luck?
- MS. LUCK: Good morning, Madam Examiner, Kaitlyn
- Luck with the Santa Fe office of Holland & Hart on behalf of
- 25 MRC Permian.

1 HEARING OFFICER ORTH: All right. We don't have

- 2 any other entries of appearance. Let's see, I do see a
- 3 seventh participant here. Hold on. Oh, Mr. Feldewert is
- 4 trying to join us. Give him a moment here. Mr. Feldewert,
- 5 are you with us?
- 6 (No audible response.)
- 7 HEARING OFFICER ORTH: I admitted him.
- 8 MR. FELDEWERT: Here I am. And I believe Kaitlyn
- 9 is on on behalf of MRC. Is that correct?
- 10 HEARING OFFICER ORTH: Yes, that's correct. She
- 11 just entered her appearance.
- MR. FELDEWERT: Wonderful. I'm going to step
- 13 out. I was on a conference call and I wanted to make sure
- 14 that we were covered, so we are in good hands now.
- 15 HEARING OFFICER ORTH: Terrific.
- MR. FELDEWERT: Thank you.
- 17 HEARING OFFICER ORTH: So we also have Irene
- 18 Delgado on this, on this call. She is transcribing the
- 19 hearing for us. Good morning, Irene. And Kurt Simmons will
- 20 be our Technical Examiner this morning.
- I believe that is now all of us on this call, and
- 22 Marlene, of course Marlene Salvidrez from the Division.
- So, Ms. Hardy, would you, would you please kick
- 24 us off.
- MS. HARDY: Yes, thank you. I want to thank

1 everyone for convening this hearing today and getting this

- 2 matter set. Mewbourne really appreciates it.
- In case 21390, Mewbourne seeks an order pooling
- 4 all uncommitted mineral interests in the Bone Spring
- 5 formation in a 323.8 acre, more or less, standard horizontal
- 6 spacing unit, comprised of the N/2 of the N/2 of Sections 3
- 7 and 4, Township 18 South, Range 32 East in Lea County.
- 8 In case 21391, Mewbourne seeks an order pooling
- 9 all mineral interests in the Bone Spring formation in a 320
- 10 acre, more or less, standard horizontal spacing unit
- 11 comprised of the S/2 of the N/2 of Sections 3 and 4,
- 12 Township 18 South, Range 32 East in Lea County.
- 13 And our exhibits include the self-affirmed
- 14 statement of landman Mitch Robb and the self-affirmed
- 15 statement of geologist Charles Crosby. Mr. Robb discusses
- 16 all of the land issues and provides the exhibits required by
- 17 the checklist.
- 18 The land information regarding ownership and the
- 19 identities of pooled parties and also the identity of the
- 20 unlocatable parties is all provided in Exhibit A-5 to Mr.
- 21 Robb's affidavit. The notice information is provided in
- 22 Exhibits A-9 and A-10 to his affidavit.
- Notice of the hearing was timely sent by
- 24 certified mail to the parties more than 20 days prior to the
- 25 hearing, and notice was also published more than ten

1 business days prior to the hearing. And that was actually

- 2 the initial hearing date that had been set in September. So
- 3 we provided all the notices that were required by the
- 4 Division's rules.
- 5 And Mr. Crosby's self-affirmed statement provides
- 6 the standard geology exhibits, provides a structure map, a
- 7 gross and isopach map, a cross section, a production table
- 8 and a well planning report that provides the directional
- 9 drilling plans for the wells.
- 10 So I think that's all the information that is
- 11 required and Mewbourne has provided it. And with that,
- 12 unless there are questions, I would request that the
- 13 exhibits be accepted into the record and that the matters be
- 14 taken under advisement.
- 15 HEARING OFFICER ORTH: Thank you, Ms. Hardy. Ms.
- 16 Luck, do you have questions?
- 17 MS. LUCK: Hi. No questions for me, thank you.
- 18 HEARING OFFICER ORTH: All right. Thank you.
- 19 Mr. Simmons, do you have questions for Ms. Hardy?
- 20 TECHNICAL EXAMINER SIMMONS: No, everything
- 21 appears to be in order. Thank you.
- 22 HEARING OFFICER ORTH: All right, thank you. In
- 23 that case, Ms. Hardy, the exhibits are admitted, and the
- 24 matters will be taken under advisement, 21390 and 21391.
- 25 (Exhibits admitted)

And I want to mention that Mewbourne has a lease expiration issue pending, so that's the reason they were very appreciative that they could have this case heard heard today and are hoping to receive an order as soon as possible.
