1 HEARING EXAMINER ORTH: Let's move then to the
2 next two matters, 21497 and 21498, Mewbourne Oil is
3 applicant, compulsory pooling application. The well name
4 is, as you know, it's the Chris Farley character, Tommy Boy.
5 Mr. Bruce, you are here for the applicant?

6 MR. BRUCE: Yes.

7 HEARING EXAMINER ORTH: I saw other appearances
8 in the record, the first by MRC Permian and the second by
9 XTO Energy, Holland & Hart appearing for both of those
10 parties. Is it you, Ms. Luck?

11 MS. LUCK: That's correct. Thank you, Madam
12 Examiner. Kaitlyn Luck with the Santa Fe office of Holland
13 & Hart on behalf of XTO and Matador.

14 HEARING EXAMINER ORTH: Thank you. Let me pause
15 for a moment to see if there are any other appearances.

16 (No audible response.)

17 HEARING EXAMINER ORTH: No? Ms. Luck, do you
18 object to Mr. Bruce proceeding by affidavit?

19 MS. LUCK: No objection. Thank you.

20 HEARING EXAMINER ORTH: All right. Thank you
21 very much. Mr. Bruce, go ahead.

22 MR. BRUCE: Madam Chair, in these two cases
23 Mewbourne seeks to pool collectively all of Sections 23 and
24 24 in 22 South, 27 East. The first case, 21497, involves
25 the N/2 -- N/2s of those sections and -- for the Tommy Boy

1 23-24 wells identified in the applications -- in the
2 application.

3 And then the second case, 21498, those Tommy Boy
4 wells cover the S/2s of those two sections. Again we have
5 the land affidavit from Brad Dunn who includes the usual
6 information required in these hearings. And I would note
7 that there is a full summary of working interests for both
8 well units identifying the parties who need to be pooled.

9 Mewbourne itself has about a 44.5 percent
10 interest, although I do know that although Kaiser-Francis
11 was officially pooled, that they are in favor of -- I have
12 been informed by Kaiser-Francis they are in favor of the
13 order being issued to Mewbourne Oil Company.

14 Again, the usual information, the AFEs are stated
15 to be fair and reasonable, and, as in all of Mewbourne's
16 cases, they are requesting 8,000 and \$800 for the overhead
17 rates.

18 And again, the geologist is Tyler Hill, and his
19 affidavit, since the geology is virtually identical, there
20 is only one affidavit for him, and it contains all of the
21 cross sections, isopachs and structure maps to show that the
22 wells should be drilled horizontally.

23 Notice was given to all the parties being pooled
24 by certified mail. And two green cards were not yet
25 returned, but notice was published, and that is shown in

1 Exhibit 5 so that all the parties did receive notice.

2 And then Exhibits 6-A and 6-B are the respective
3 pooling checklists for the two cases.

4 And, again, I believe the exhibit package is
5 complete, and I would ask that the matter be taken --
6 matters be taken under advisement.

7 HEARING EXAMINER ORTH: All right. Thank you,
8 Mr. Bruce. Ms. Luck, do you have questions?

9 MS. LUCK: No questions and no objections to the
10 exhibits being admitted.

11 HEARING EXAMINER ORTH: Thank you very much. Mr.
12 Rose-Coss, do you have questions?

13 TECHNICAL EXAMINER COSS: No questions.

14 HEARING EXAMINER ORTH: All right, thank you.
15 Mr. Bruce, your exhibits are admitted and the matters will
16 be taken under advisement.

17 MR. BRUCE: Thank you.
