APPLICANT'S STATEMENT OF CASE

Ameredev seeks an order pooling all uncommitted interests in the Wolfcamp formation, underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the E/2 E/2 of Sections 30 and 31, and the W/2 W/2 of Sections 29 and 32, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico. Ameredev proposes to dedicate the above-referenced spacing unit to the following initial wells:

- The **Nandina Fed Com 25 36 31 107H Well**, and the **Nandina Fed Com 25 36 31 127H Well**, both of which are to be drilled from a common surface hole location in the SE/4 SE/4 (Unit P) of Section 31 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 30; and
- The **Redbud Fed Com 25 36 32 102H Well**, and the **Redbud Fed Com 25 36 32 112H Well**, both of which are to be drilled from a common surface hole location in the SW/4 SW/4 (Unit M) of Section 32 to bottom hole locations in the NW/4 NW/4 (Unit D) of Section 29.

The completed interval for the proposed **Redbud Fed Com 25 36 32 102H Well** will be within 330' of the quarter-quarter line separating the E/2 E/2 of Sections 30 and 31 from the W/2 W/2 of Sections 29 and 32 to allow inclusion of this acreage into a standard 640-acre horizontal spacing unit.
