APPLICANT'S STATEMENT OF CASE

Centennial seeks an order pooling all uncommitted interests in the Bone Spring formation (Bilbrey Basin; Bone Spring Pool (Pool Code 5695)) underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the E/2 W/2 and the W/2 E/2 of Section 5, Township 22 South, Range 32 East, and the E/2 W/2 and the W/2 E/2 of Section 32, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Centennial proposes to dedicate the above-referenced spacing unit to the following proposed initial wells:

- The **Mozzarella Fed Com #602H Well** (API No. 30-025-46742) to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 8, Township 22 South, Range 32 East, to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 32;
- The **Mozzarella Fed Com #603H Well** (API No. 30-025-46757) to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 8, Township 22 South, Range 32 East, to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 32; and
- The **Gouda Fed Com #604H Well** (API No. 30-025-pending) to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 5, to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 32.

The completed interval of the **Mozzarella Fed Com #603H well** will remain within 330 feet of the quarter-quarter line separating the E/2 W/2 from the W/2 E/2 to allow inclusion of these proximity tracts into a standard 640-acre horizontal spacing unit. Centennial intends to seek administrative approval of the non-standard location of the **Gouda Fed Com #604H Well**.
