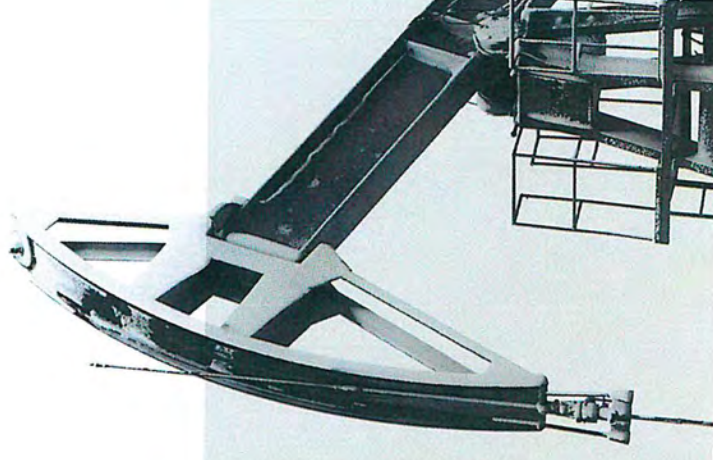

**SELF-AFFIRMED STATEMENT OF
MEGAN TIPTON**

1. I am over 18 years of age and am competent to provide this Self-Affirmed Statement. I have personal knowledge of the matters addressed herein.

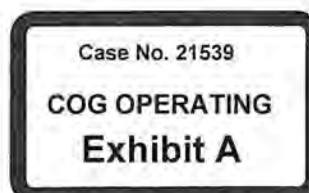
2. I am a landman for COG Operating LLC ("COG"). I have had direct involvement with COG's development of the 400.83-acre, more or less, standard horizontal spacing unit ("HSU") that is the subject of COG's application in this case. A copy of the application and proposed notice are attached as Exhibit A-1.

3. I have previously testified before the Division, and my qualifications as an expert in petroleum land matters were accepted.

A. Proposed Horizontal Spacing Unit

4. The proposed HSU is comprised of the W/2 E/2 of Section 9, Township 25 South, Range 35 East, Lot 2, SW/4 NE/4 and W/2 SE/4 of irregular Section 4 (W/2 E/2 equivalent), Township 25 South, Range 35 East, and the W/2 SE/4 of Section 33, Township 24 South, Range 35 East in Lea County, New Mexico.

5. COG seeks to pool all uncommitted interests in the Wolfbone Pool (Code 98098), WC-025 G-09 S243532M, underlying the HSU.



6. The HSU will be dedicated to the Fez Federal Com #710H well, which will be horizontally drilled from a surface location in Unit O of Section 9, Township 25 South, Range 35 East to a bottom hole location in Unit J of Section 33, Township 24 South, Range 35 East. The first take point for the well is 100' FSL and 1,650' FEL in Section 9, and the last take point is 2,540' FSL and 1,650' FEL in Section 33. The target interval is the Wolfbone Pool at 12,400' TVD and 24,950 TMD.

7. The proposed well will be completed from South to North, and the completed interval of the well will be orthodox.

8. With respect to well setback requirements, the Wolfbone Pool is subject to the statewide horizontal well rules set out in NMAC 19.15.16.15. Spacing in this pool is based on quarter-quarter sections, and the HSU is constructed based on quarter-quarter sections.

9. The C-102 for the proposed well is attached as Exhibit A-2.

B. Ownership Determination

10. Exhibit A-3 identifies the tracts of land comprising the proposed HSU, the working interest ownership in each tract, and the ownership interests in the HSU. The parties COG seeks to pool are highlighted, and unlocatable parties are marked with an asterisk.

11. There is no depth severance in the Wolfbone Pool in the proposed HSU.

C. Joinder

12. I sent well proposal letters to the uncommitted interests on October 2, 2020 and subsequently had follow-up communications with many of them. My well proposal letter is attached as Exhibit A-4. A summary of my follow-up contacts with the uncommitted interests is attached as Exhibit A-5.

13. COG's counsel received a letter dated November 20, 2020 from Tiffany A. Feet and a letter dated November 23, 2020 from Bradford Jones, copies of which are provided in Exhibit A-6. Although Ms. Feet and Mr. Jones state that they object to COG's applications, neither party entered an appearance. According to land ownership records, Ms. Feet is a potential heir of a 1/1728 mineral interest in the well, and Mr. Jones is a potential heir of a 56/107003 mineral interest in the well.

14. 91.36% of the working interests are committed to the proposed well.

15. In my opinion, COG has made a good faith effort to obtain the voluntary joinder of uncommitted interests in the proposed wells.

D. Drilling and Operating Costs

16. The AFEs for the proposed wells are attached as Exhibit A-7. The estimated cost of the well is fair and reasonable and is comparable to the cost of other wells of similar depth and length drilled in Lea County.

17. COG requests overhead and administrative rates of \$8,000 per month while the well is being drilled and \$800 per month while the well is producing. These rates are fair and are comparable to the rates charged by COG and by other operators in the vicinity. They are also the rates set forth in the Joint Operating Agreement for the HSU. COG further requests that the rates be adjusted periodically in accordance with the COPAS Accounting Procedure.

18. COG requests that it be designated the operator of the well.

19. COG also requests that a 200% risk charge be assessed against the uncommitted interests if they are non-consenting working interest owners.

E. Notice of Hearing

20. At my direction, notice of COG's application and the Division hearing was provided to the uncommitted interests at least 20 days prior to the hearing date. The notice letter and associated receipts are attached as Exhibit A-8.

21. Notice of COG's application and the Division hearing was published more than ten business days prior to the hearing date. The affidavit of publication is attached as Exhibit A-9.

22. COG conducted a diligent, good-faith effort to identify the correct addresses of persons entitled to notice and has complied with the Division's notice requirements.

23. The attached exhibits attached were either prepared by me or under my supervision, or were compiled from company business records.

24. In my opinion, the granting of COG's application would serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

25. I understand that this Self-Affirmed Statement will be used as written testimony in this case. I affirm that my testimony in paragraphs 1 through 24 above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico. My testimony is made as of the date handwritten next to my signature below.

APPLICATION

Pursuant to NMSA § 70-2-17, COG Operating LLC ("COG") applies for an order pooling all uncommitted mineral interests in the WC-025 G-09 S243532M; Wolfbone Pool (98098) underlying a 400.83-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 9, Township 25 South, Range 35 East, Lot 2, SW/4 NE/4 and W/2 SE/4 of irregular Section 4 (W/2 E/2 equivalent), Township 25 South, Range 35 East, and the W/2 SE/4 of Section 33, Township 24 South, Range 35 East in Lea County, New Mexico. In support of its Application, COG states the following.

1. COG (OGRID No. 229137) is a working interest owner in the proposed horizontal spacing unit and has the right to drill wells thereon.
2. The horizontal spacing unit will be dedicated to the Fez Federal Com #710H well, which will be horizontally drilled from a surface location in Unit O of Section 9, Township 25 South, Range 35 East to a bottom hole location in Unit J of Section 33, Township 24 South, Range 35 East.
3. The completed interval of the well will be orthodox.
4. COG has undertaken diligent, good-faith efforts to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well but has been unable to obtain voluntary agreements from all of the mineral interest owners.

5. The pooling of all uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

6. In order to allow COG to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted mineral interests in the horizontal spacing unit should be pooled and COG should be designated the operator of the proposed horizontal well.

WHEREFORE, COG requests that this Application be set for hearing on December 3, 2020 and that, after notice and hearing, the Division enter an order:

- A. Pooling all uncommitted mineral interests in the horizontal spacing unit;
- B. Designating COG as the operator of the Fez Federal Com #710H well;
- C. Authorizing COG to recover its costs of drilling, equipping, and completing the well and allocating the costs among the well's working interest owners;
- D. Approving the actual operating charges and costs of supervision during drilling and after completion, together with a provision for adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Imposing a 200% penalty for the risk assumed by COG in drilling and completing the Fez Federal Com #710H well against any mineral interest owner who does not voluntarily participate in the drilling of the well.

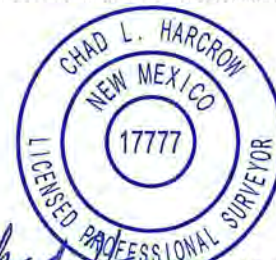

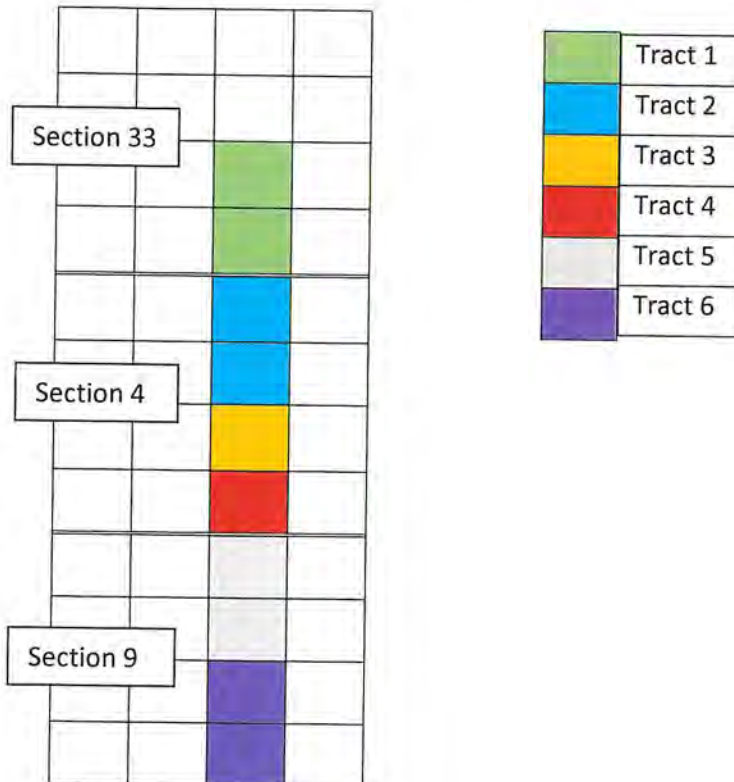

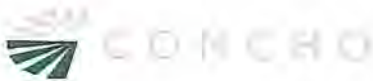

COG Operating LLC (“COG”), as Operator, hereby proposes the drilling of the following horizontal well with productive laterals located in the W/2E/2 of Sections 4 and 9, T25S-R35E and the W/2SE/4 of Section 33, T24S-R35E, Lea County, New Mexico (collectively, the “Operation”). The surface pad location will be located in Unit Letter O of Section 9, T25S-R35E (or another location chosen by Operator).

- **FEZ FEDERAL COM #710H**, to be drilled to a depth sufficient to test the Wolfbone Pool at an approximate total vertical depth of 12,400 feet. The estimated surface hole location for this well is proposed at approximately 330’ FSL, 1570’ FEL of Section 9 or a location in unit letter O of Section 9. The first take point for this well is estimated at approximately 100’ FSL, 1,650’ FEL of Section 9, and the last take point is estimated at approximately 2,540’ FSL, 1,650’ FEL of Section 33. The estimated bottom hole location for this well is proposed at approximately 2,590’ FSL, 1,650’ FEL of Section 33 or a location in Unit J of Section 33. 1. I am over 18 years of age and am competent to provide this Self-Affirmed Statement. I have personal knowledge of the matters addressed herein.

2. I am a geologist at COG Operating LLC ("COG"). I have previously testified before the New Mexico Oil Conservation Division, and my credentials as an expert in petroleum geology were accepted.

3. I am familiar with the geological matters that pertain to COG's application.

4. The target interval for the Fez Federal Com #710H well is in the Wolfbone Pool, within the Bone Spring and Wolfcamp Formations underlying the subject acreage.

5. Exhibit B-1 is a location map that shows the proposed Fez Federal Com #710H well in relation to surrounding development in the Wolfcamp Formation and Third Bone Spring Sand. The standup orientation of the proposed well is consistent with the surrounding development and suggest this is the preferred orientation.

6. Exhibit B-2 is a subsea structure map of the top of the Wolfcamp Formation that is representative of the target interval within the Bone Spring and Wolfcamp Formations. The proposed spacing unit is highlighted in yellow and the proposed well is depicted with a dashed line. The contour intervals are 100 feet and show the structure dipping to the west. The structure

appears consistent across the proposed spacing unit and I do not observe any faulting, pinch outs, or other geologic impediments to drilling horizontal wells.

7. Exhibit B-3 contains a line of cross section from A to A' using two wells. I chose these wells because they contain a good set of well logs and are representative of the geology in the subject area.

8. Exhibit B-4 is a stratigraphic cross-section that I prepared using the representative wells shown on Exhibit B-3. Each well on the cross-section contains gamma ray, resistivity, and porosity logs. The target interval for the well is bracketed. The cross-section demonstrates that the target interval is continuous across the proposed spacing unit.

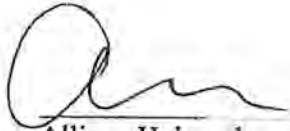
9. Based on my geologic study, I am able to conclude that:

11. The attached exhibits were either prepared by me or compiled from company records.

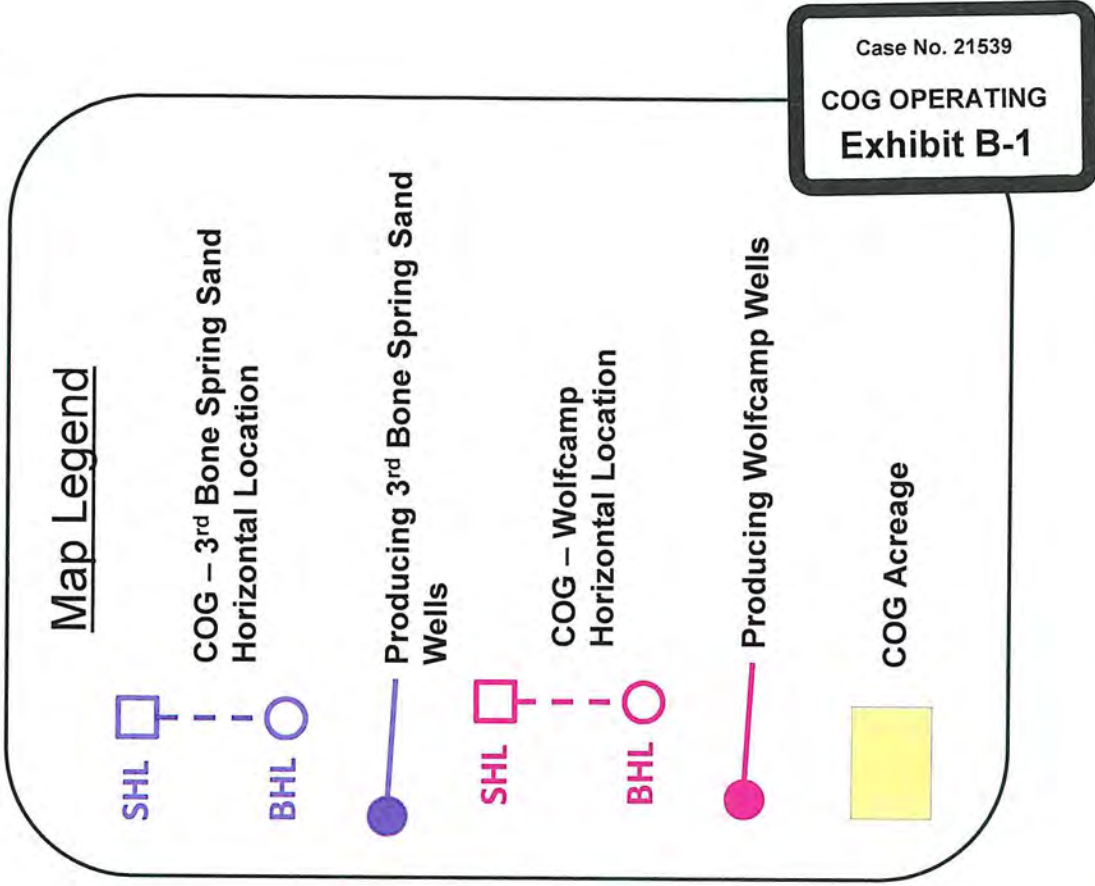
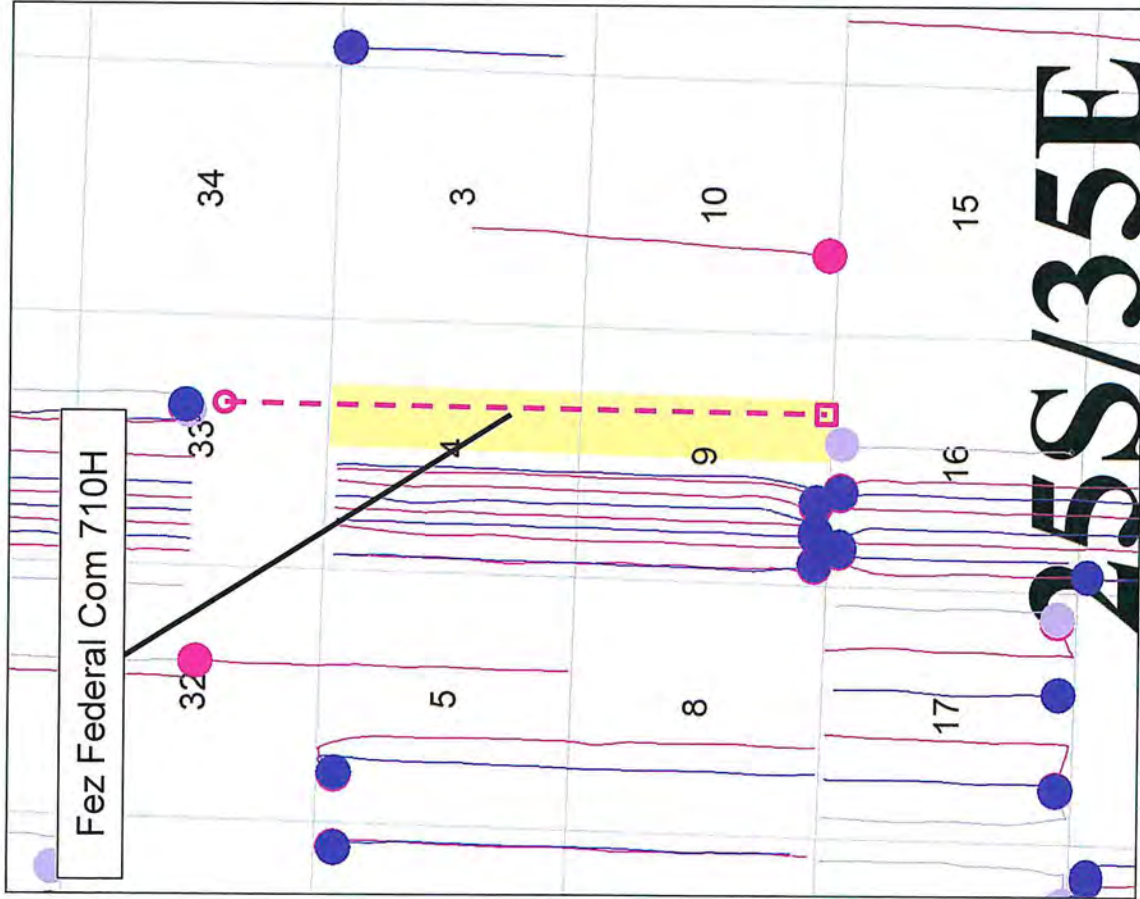

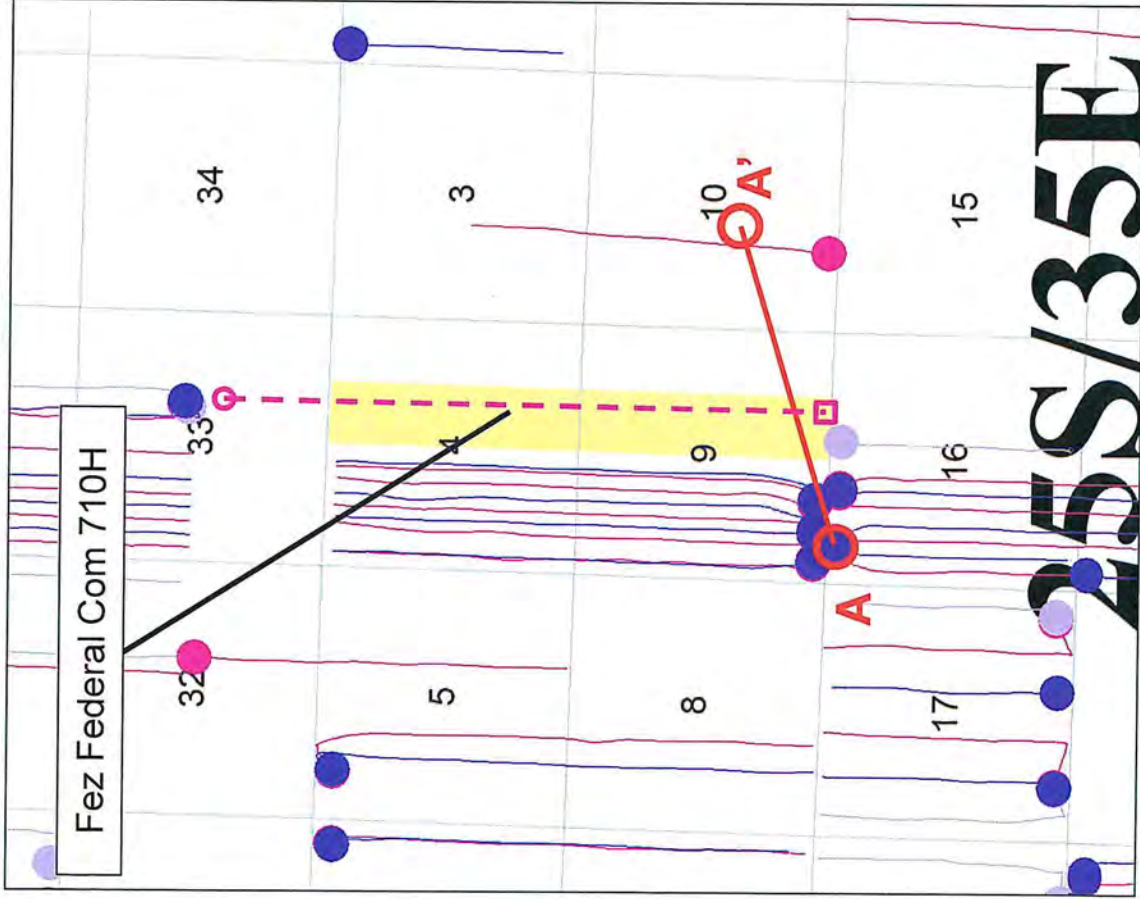


Wolfcamp Subsea Structure Map Wolfbone Pool

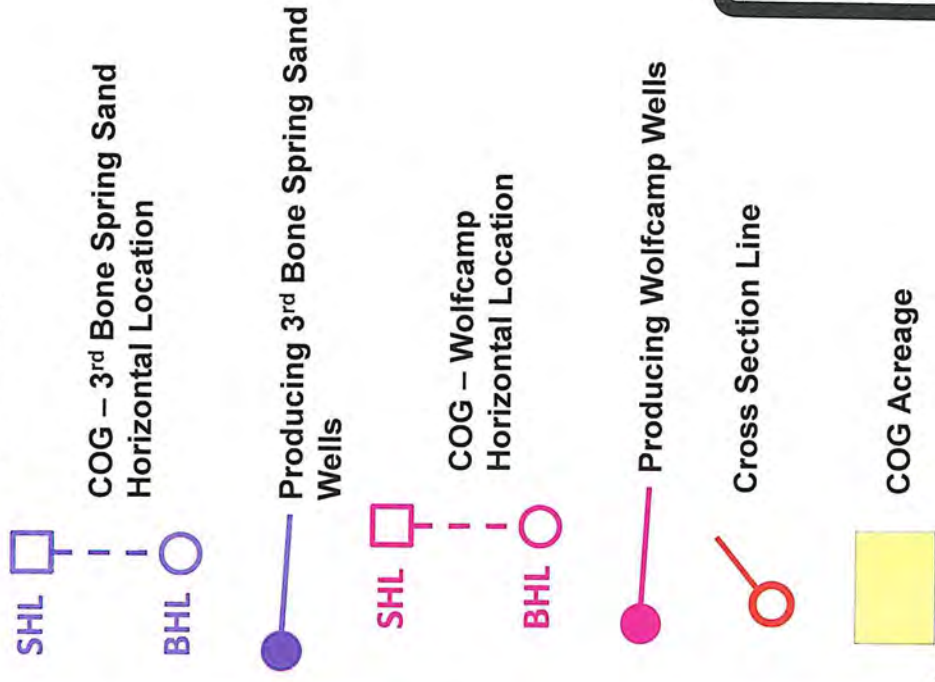

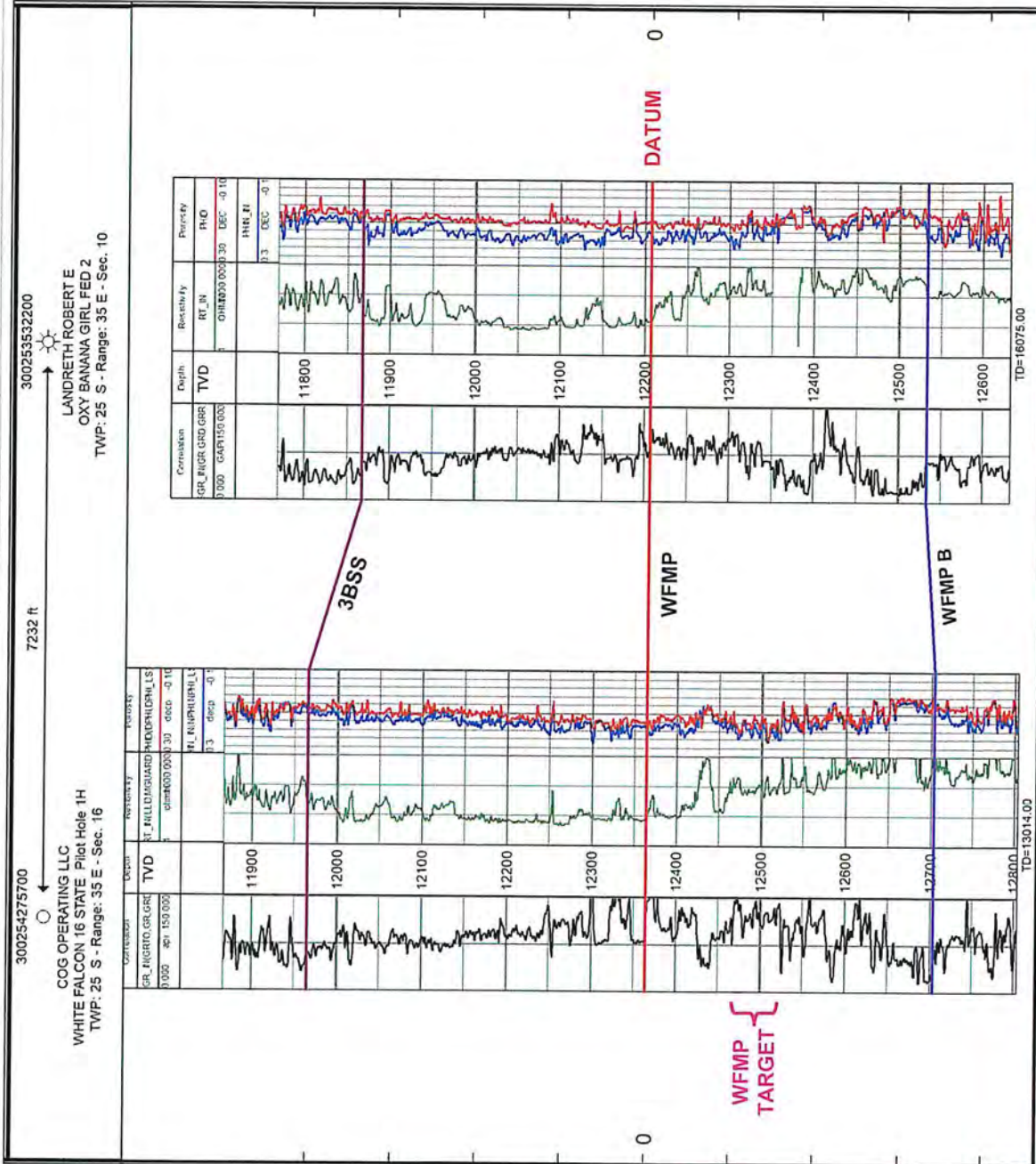
