**APPLICANT’S STATEMENT OF CASES**

In Case No. 21633, Devon seeks to reopen Case No. 20962, in order to request a one-year extension of the well commencement deadline in the Order, which was issued April 18, 2020. This Order pooled all uncommitted interests in the Bone Spring formation underlying the W/2 of Sections 20 and 29, Township 23 South, Range 33 East, NMPM, Lea County, New Mexico, and granted Devon the operating rights for development of these lands as a unit. Paragraph 20 of the Order allows for an extension by amendment for good cause shown, and Devon on the basis of good cause show, requests a one-year extension of the well commencement deadline, through April 18, 2022.
