APPLICANT’S STATEMENT OF CASE

In Case No. 21679, Devon seeks to reopen Case No. 21266, in order to request a one-year extension of the well commencement deadline in Order R-21081-A, which the Division issued May 20, 2020. This Order pooled all uncommitted interests in the Bone Spring formation underlying the W/2 of Section 24, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico, and granted Devon the operating rights for development of these lands as a unit. Paragraph 14 of the Order allows for an extension by amendment for good cause shown. Devon will present the basis of good cause to allow for the extension and, based on that showing, requests a one-year extension of the well commencement deadline, through May 20, 2022.
