**APPLICATION**

Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, Section 70-2-17, for an order (1) creating a standard 1280-acre, more or less, spacing and proration unit comprised of Sections 13 and 14, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico (“Subject Lands”), and (2) pooling all uncommitted mineral interests in the Wolfcamp formation, designated as a gas pool, underlying said unit.

In support of its Application, Devon states the following:

1. Devon is a working interest owner in the proposed horizontal spacing and proration unit (“HSU”) and has a right to drill a well thereon; and therefore, Devon proposes to drill two initial wells in the HSU: (1) the **Lone Tree Draw 14-13 State Com 623H Well**, and (2) the **Lone Tree Draw 14-13 State Com 621H Well**.

2. Devon had previously submitted pooling applications, currently pending, for the Lone Tree Draw 14-13 State Com 621H and 623H Wells in Case Nos. 21521 and 21522, respectively, which requested pooling of the Alacran Hills Upper Wolfcamp Oil [98314] formation, based on prior pooling history of the Subject Lands in Case No. 20160 and Division

Order No. R-20490. The 621H Well had been proposed for the N/2 N/2 of said Sections 13 and 14, and the 623H Well had been proposed for the N/2 S/2 of said Sections 13 and 14, because the Alacran Hills Upper Wolfcamp Oil Pool is based on 40-acre blocks. However, after discussions with Division geologists regarding the status of the Alacran Hills Upper Wolfcamp Oil Pool, Devon submits this new application in order to pursue the pooling of the Wolfcamp formation as it relates to the Alacran Hills Wolfcamp Gas Pool, which is based on 160-acre building blocks, and therefore, requires a larger spacing size. This new application is submitted to amend and supplant the prior applications filed in Case Nos. 21521 and 21522.

3. Devon proposes to dedicate the HSU to its **Lone Tree Draw 14-13 State Com 623H Well**, proposed to be drilled to a sufficient vertical depth to test the Wolfcamp formation and proposed to be horizontally drilled from a surface location in NW/4 SW/4 (Unit L) of Section 14 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 13. The **Lone Tree Draw 14-13 State Com 623H Well** is the Proximity Well for the HSU.

4. Devon also proposes to dedicate the HSU to its **Lone Tree Draw 14-13 State Com 621H Well**, proposed to be horizontally drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 14 to a bottom hole location in NE/4 NE/4 (Unit A) of Section 13.

5. Currently, Devon has well location setbacks at 330' which conform to statewide rules and regulations. Devon is considering the first and last take points of the completed intervals for the proposed wells in the HSU to be 100' setbacks instead of the 330' setbacks, and if such adjustment should be decided, Devon would apply administratively for approval of the nonstandard locations and send notice to affected parties during the administrative application.

6. Pursuant to NMAC 19.15.16.15(B)(3)(b), Devon will incorporate proximity tracts into its HSU so that the size of the unit will be a standard 1280-acre, more or less, spacing unit.

7. Devon has sought in good faith, with the original well proposals, and follow up communications, but has been unable to obtain, voluntary agreement from the interest owners to participate in the drilling of the wells or in the commitment of their interests to the well for its development within the proposed HSU. Devon has provided updated proposals and notices based on changes in spacing and well location, described herein, and has maintained communication and negotiations regarding such matters.

8. The pooling of all interests in the Wolfcamp formation within the proposed HSU, and creation of the spacing unit, will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights.

9. In order to provide for its just and fair share of the oil and gas underlying the subject lands, Devon requests that all uncommitted interests in this HSU be pooled and that Devon be designated the operator of the proposed horizontal wells and HSU.

WHEREFORE, Devon requests that this Application be set for hearing before an Examiner of the Oil Conservation Division on March 4, 2021, and after notice and hearing as required by law, the Division enter an order:

A. Approving the creation of a standard 1280-acre, more or less, spacing and proration unit comprising Sections 13 and 14, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico;

B. Pooling all uncommitted mineral interests in the Wolfcamp formation underlying the proposed HSU.

C. Designating the **Lone Tree Draw 14-13 State Com 623H Well** as the Proximity Well for the HSU, and approving the **Lone Tree Draw 14-13 State Com 621H and 623H Wells** for the HSU.

D. Designating Devon as operator of this HSU and the horizontal wells to be drilled thereon;

E. Authorizing Devon to recover its costs of drilling, equipping and completing the wells;

F. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

G. Setting a 200% charge for the risk assumed by Devon in drilling and completing the wells in the event a working interest owner elects not to participate in the well.


*Application of Devon Energy Production Company L.P. for a Horizontal Spacing and Proration Unit and Compulsory Pooling, Eddy County, New Mexico.* Applicant in the above-styled cause seeks an order from the Division: (1) creating a standard 1280-acre, more or less, horizontal spacing and proration unit comprised of the Sections 13 and 14, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico, and (2) pooling all mineral interests in the Wolfcamp formation, designated as a gas pool, underlying the unit. Said horizontal spacing unit is to be dedicated to the proposed **Lone Tree Draw 14-13 State Com 621H and 623H Wells**. The **Lone Tree Draw 14-13 State Com 623H Well** to be horizontally drilled from a surface location in NW/4 SW/4 (Unit L) of Section 14 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 13. This Well will be the proximity well for the HSU. The **Lone Tree Draw 14-13 State Com 621H Well** is to be horizontally drilled from a surface location in SW/4 NW/4 (Unit E) of Section 14 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 13. Proximity tracts will be incorporated into the unit. Nonstandard locations may be considered, and Applicant would apply administratively for their approval if considered. Also to be considered will be the cost of drilling and completing the well and the allocation of the costs thereof; actual operating costs and charges for supervision; the designation of the Applicant as operator of the wells and unit; and a 200% charge for the risk involved in drilling and completing the well. The well and lands are located approximately 3 miles northeast of Carlsbad, New Mexico.



I, being duly sworn on oath, state the following:

1. I am over the age of eighteen years and have the capacity to execute this Affidavit, which is based on my personal knowledge.
2. I am employed as a Senior Staff Landman with Devon Energy Production Company, L.P. (“Devon”), and I am familiar with the subject application and the lands involved.
3. I graduated from the University of Oklahoma with a Bachelor’s degree in Business (Energy Management) in 2008. I have worked at Devon for approximately 11 years, and I have been working in New Mexico for 2 1/2 years. My credentials as a petroleum landman have been accepted by the New Mexico Oil Conservation Division (“Division”) and made a matter of record.
4. This affidavit is submitted in connection with the filing by Devon of the above-referenced spacing and compulsory pooling application pursuant to 19.15.4.12.A(1) NMAC.
5. The purpose of this application is to force pool uncommitted working interest owners and overriding royalty interest owners into the horizontal spacing unit described below, and in the wells proposed to be drilled in the unit by Devon.



Devon seeks an order for (1) creating a standard 1280-acre, more or less, spacing and proration unit comprised of Sections 13 and 14, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Wolfcamp formation (Alacran Hills; Wolfcamp (Gas) Pool [Code 70070]), a gas pool, underlying said unit.

6. Devon proposes to dedicate the unit to its **Lone Tree Draw 14-13 State Com 623H Well**, proposed to be drilled to a sufficient vertical depth to test the Wolfcamp formation and proposed to be horizontally drilled from a surface location in NW/4 SW/4 (Unit L) of Section 14 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 13. The **Lone Tree Draw 14-13 State Com 623H Well** is the Proximity Well for the unit.

7. Devon also proposes to dedicate the HSU to its **Lone Tree Draw 14-13 State Com 621H Well**, proposed to be horizontally drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 14 to a bottom hole location in NE/4 NE/4 (Unit A) of Section 13.

8. A plat outlining the unit being pooled is attached hereto as **Exhibit A-2**, and the C-102s are attached as **Exhibit A-1**, both which shows the location of the proposed wells within the unit. The location of all the wells is unorthodox, the take points being 100' from the boundary of the unit, and therefore Devon plans to apply administratively for approval of the nonstandard locations.

9. The parties being pooled, the nature of their interests, and their last known addresses are listed on **Exhibit A-2** attached hereto. **Exhibit A-2** includes information regarding working interest owners and overriding royalty interest owners.

10. There are no depth severances in the Wolfcamp formation in this acreage.

11. The locations and proposed depths of the wells to be drilled on the pooled units are as follows:

12. I provided the law firm of Abadie & Schill P.C. a list of names and addresses for the uncommitted interest owners and ORRI owners shown on Exhibit A-2. In compiling these addresses, I conducted a diligent search of the public records in Eddy County, New Mexico, where the wells are located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. Because not all parties were locatable, notice of this hearing was published in the Carlsbad Current-Argus, a newspaper of general circulation in Eddy County, New Mexico, to cover any unlocatable parties. There were 5 unlocatable parties: Betsy H. Keller, EG Holden Testamentary Trust, Adolph P. Shuman Trust, Elouise H. Justice, and T.K. Campbell, II. The post office lists letters as still in transit for the following 4 parties: McCombs Energy, Tennison Oil Co., Tumbler Operating Partners, LLC, and Kimbell Royalty Holdings, LLC.

13. Devon has made a good faith effort to obtain voluntary joinder of the working interest owners in the proposed wells. **Exhibit A-4** provides a chronology and history of contacts with the owners.

14. The interest owners being pooled have been contacted regarding the proposed wells, but have failed or refused to voluntarily commit their interests in the wells. However, Devon has been

in ongoing discussions with some of the interest owners to voluntarily enter into a Joint Operating Agreement. If a mutually agreeable Joint Operating Agreement is reached between Devon and another interest owner or owners, Devon requests that the voluntary agreement become operative and supersede the Division's order for said parties, except to the extent the Division deems it necessary to maintain spacing criteria for the purpose of conservation, the prevention of waste, and the protection of correlative rights. All working interest owners are subject to an existing lease.

15. Proposed C-102s for the wells are attached as **Exhibit A-1**. The wells will develop the Wolfcamp formation (Alacran Hills; Wolfcamp (Gas) Pool [Code 70070]), an existing gas pool within the Permian Basin. Devon has also made progress on the development of these wells by obtaining approval of APDs, in which the 621H and the 623H Wells have been assigned API Nos. 30-015-46403 and 30-015-46435, respectively.

16. **Exhibit A-3** is a sample proposal letter and the AFE for the proposed wells. The estimated cost of the wells set forth in the AFE is fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

17. Devon requests overhead and administrative rates of \$8,000/month for drilling the wells and \$800/month for producing the wells. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of southeastern New Mexico. Devon requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

18. Devon requests the maximum cost, plus 200% risk charge be assessed against non-consenting working interest owners.

19. Devon requests that it be designated operator of the unit and wells.

20. The Exhibits to this Affidavit were prepared by me or compiled from Devon's company business records under my direct supervision.

21. The granting of this Application is in the best interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

22. The foregoing is correct and complete to the best of my knowledge and belief.





**AFFIDAVIT OF JOSEPH DIXON**

I, Joseph Dixon, being duly sworn on oath, state the following:

1. I am over the age of 18, and I have personal knowledge of the matters stated herein.
2. I am employed as a petroleum geologist for Devon Energy Production Company, L.P. (“Devon”), and I am familiar with the subject application and the geology involved.
3. This affidavit is submitted in connection with the filing by Devon of the above-referenced compulsory pooling application pursuant to 19.15.4.12.A(1) NMAC.
4. I have previously testified by affidavit before the Oil Conservation Division (“Division”) and have been accepted, based on my credentials, as an expert witness in geology. I had previously submitted a one-page resume for the Division’s consideration, and if requested or needed, I would be glad to provide an additional copy for review. My educational and working background is as follows:
  - a. I hold a Bachelor’s degree in Geology obtained from Purdue University, a Master’s degree in Geology from Oklahoma State University. I completed my education in 2013.
  - b. I have been employed as a petroleum geologist with Devon since June, 2013.
5. **Exhibit B-1** is a structure map, with a contour interval of 10’, showing the depth (subsea) to the top of the Wolfcamp formation, a marker that defines the top of target interval for the

proposed wells. The proposed spacing units are outlined by a red rectangle and the proposed horizontal wells are shown. I do not see any faults, pinch-outs or other major structural impediments to developing the Wolfcamp formation with horizontal wells. Exhibit B-1 also identifies the four wells used to create a stratigraphic cross-section for the Wolfcamp formation running from A to B. I chose these wells because they have good logs and are representative of the geology in the area.

6. **Exhibit B-2** is a stratigraphic cross-section flattened on the top of the Wolfcamp. Each well in the cross-section contains a gamma ray, resistivity, and porosity log. The targeted intervals for the proposed wells are shown by a square with well number. The cross-section demonstrates continuity and consistent thickness of the target zone.

7. Additional exhibits for the benefit of the Division's review include Exhibit B-3, a gross isochore of the Wolfcamp XY, as well as Exhibits B-4 and B-5. Exhibit B-4 is a gun barrel representation of the unit, and Exhibit B-5 is a cross section with well trajectories.

8. I conclude from the attached exhibits that:

- a. The horizontal spacing and proration unit is justified from a geologic standpoint.
- b. There are no structural impediments or faulting that will interfere with horizontal development.
- c. Each quarter section building block in the unit will contribute more or less equally to production.

9. The preferred well orientation in this area is east-west.

10. The Exhibits to this Affidavit were prepared by me or compiled from Devon's company business records under my direct supervision.

11. The granting of this Application is in the interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

12. The foregoing is correct and complete to the best of my knowledge and belief.












Exhibit B-4 is a gun barrel representation of the unit.




Exhibit B-5 is a cross section with well trajectories.
