APPLICANT'S STATEMENT OF CASE

Following a hearing on a set of consolidated pooling cases, the Division entered the following pooling orders on April 9, 2020:

- Under Case 21037, the Division entered **Order No. R-21208** creating a standard 160-acre horizontal spacing unit in the First Bone Spring Interval of the Bone Spring formation (Laguna Salado; Bone Spring pool [96721]) from a depth of 7,702 feet to 7,839 feet underlying the W/2 W/2 of Section 15, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico (the "Unit"). The Order dedicated the Unit to the proposed **Saturninus Fed Com No. 111H well** (API No. 30-015-pending).
- Under Case 21038, the Division entered **Order No. R-21209** creating a standard 320-acre horizontal spacing unit in the Bone Spring formation (Laguna Salado; Bone Spring pool [96721]) from a depth of 7,839 feet to the base of the Bone Spring formation underlying the W/2 W/2 of Sections 10 and 15, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico (the "Unit"). The Order dedicated the Unit to the proposed the **Saturninus Fed Com 1510 Nos. 121H** and **131H** wells (API Nos. pending).
- Under Case 21039, the Division entered **Order No. R-21210** creating a standard 320-acre horizontal spacing unit in the Bone Spring formation (Laguna Salado; Bone Spring pool [96721]) from a depth of 7,839 feet to the base of the Bone Spring formation underlying the E/2 W/2 of Sections 10 and 15, Township 23 South, Range

- 29 East, NMPM, Eddy County, New Mexico (the "Unit"). The Order dedicated the Unit to the proposed the **Saturninus Fed Com 1510 Nos. 122H** and **132H** wells (API Nos. pending).
- Under Case 21040, the Division entered **Order No. R-21211** creating a standard 640-acre horizontal spacing unit in the Wolfcamp formation in the (Purple Sage-Wolfcamp Gas Pool [98220]) underlying the W/2 of Sections 10 and 15, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico (the "Unit"). The Order dedicated the Unit to the proposed **Saturninus Fed Com 1510 Nos. 211H, 212H, 215H, 221H, 222H, 225H, 231H, 232H,** and **235H** wells (API Nos pending).

Each Order designates Applicant as the operator of the Unit and requires drilling to commence within a year (April 9, 2021). For good cause, Applicant requests a one-year extension of the drilling deadline under each Order to April 9, 2022.
