**JOINT MOTION TO VACATE PRE-HEARING ORDER  
AND SET A STATUS CONFERENCE**

EOG Resources, Colgate Corporation and Mewbourne Oil Company (collectively the “Movants”) request that the Division vacate the pre-hearing order entered in these matters and set these matters for a status conference on the July 15, 2021, hearing docket. In support thereof, the Movants state:

1. On January 21, 2012, the Division entered a Prehearing Order setting these contested pooling cases for a hearing on April 22, 2021.
2. Since that time, EOG, Colgate and Mewbourne have been engaged in productive trade discussions that they believe may resolve all or parts of these contested cases.
3. In order to avoid a potentially unnecessary hearing, and to allow the trade discussions to continue uninterrupted, the Movants request that the prehearing order be vacated and the matters set for a status conference on the July 15th hearing docket.
4. Counsel for Yates Energy Corporation, Jalapeno Corporation, Chi Energy, Inc., and MRC Delaware Resources, LLC, who have also appeared in these matters, have been contacted and do not oppose this motion.

WHEREFORE, the Movants request the pre-hearing order and April 22nd hearing date for these matters be vacated and that these matters be scheduled for a status conference on July 15, 2021.
