2 HEARING EXAMINER BRANCARD: So then Case 21933,
3 same well family, Mewbourne Oil Company for an amendment.

4 Hinkle Shanor.

5 MR. RODRIGUEZ: Yes. Michael Rodriguez with
6 Hinkle Shanor on behalf of Mewbourne Oil Company.

7 HEARING EXAMINER BRANCARD: MRC Permian, are you
8 involved in this case, luck?

9 MS. LUCK: Yes. Kaitlyn Luck with the Santa Fe
10 office of Holland & Hart again for MRC Permian.

11 HEARING EXAMINER BRANCARD: Do you have any
12 objection to this case going ahead by affidavit.

13 MS. LUCK: No objection. Thank you.

14 HEARING EXAMINER BRANCARD: Any other parties
15 interested in case 21933, No. 28 on our docket. (Note:
16 Pause.) Hearing none, Mr. Rodriguez you may proceed.

17 MR. RODRIGUEZ: In this case Mewbourne seeks to
18 pool additional interest owners under the terms of
19 Division Order No. R-21053.

20 This Order pooled all the committed
21 interests within the Bone Spring Formation to form a
22 240-acre, more or less, standard horizontal spacing unit
23 comprised of the north half/south half of Section 13,
24 Township 19 South, Range 28 East, and the north
25 half/southwest quarter of Section 18 Township 19 South,

1 Range 29 East in Eddy County.

2 The Order further designated Mewbourne as
3 the operator of the unit.

4 On December 15th, 2020, the Division
5 granted Mewbourne's request for a time extension to
6 commence drilling the wells under the Order to January 31,
7 2022.

8 Since the Order extensions were issued,
9 Mewbourne determined there are additional interest owners
10 in the unit whose interests should be pooled under the
11 terms of the Order.

12 The case packet admitted to the Division
13 contains Exhibit A, which is the landman's affidavit and
14 related attachments, and Attachment A-6 and A-7, which are
15 the sample Notice of Hearing Letters and Affidavit of
16 Publication reflecting all Notice requirements have been
17 met.

18 With that I ask that this exhibit packet
19 containing Exhibit A, along with Attachments A-1 through
20 A-8 be admitted into the record, and Case 21933 be taken
21 under advisement.

22 HEARING EXAMINER BRANCARD: Thank you. Any
23 questions or concerns?

24 Ms. Luck?

25 MS. LUCK: None for MRC. Thank you.

1 HEARING EXAMINER BRANCARD: Mr. Lowe, any
2 questions?

3 EXAMINER LOWE: I have no questions. Thank you.

4 HEARING EXAMINER BRANCARD: Once again, are
5 there any other interested parties in Case 21933? (Note:
6 Pause.) Hearing none, the exhibits will be admitted into
