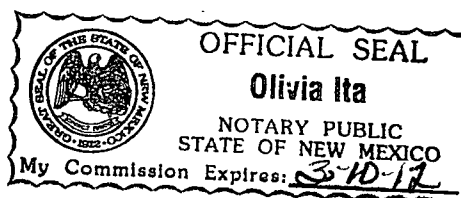


Ladies and Gentlemen:

This application has been set for hearing before a Division Examiner at 8:15 a.m. on April 28, 2011. 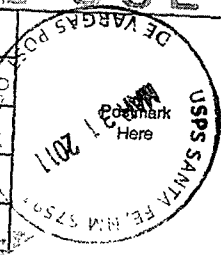
