Gentlemen:

The Second Revision to the Consolidated Delaware Formation Participating Area "BDEFH" is hereby approved effective as of November 1, 2012, pursuant to Section 11 of the Poker Lake Unit Agreement, Eddy County, New Mexico.

The application enlarges the Consolidated Delaware Formation Participating Area "BDEFH" from 6,891.58 acres to 7,291.58 acres and is based upon the completion of unit well 320H, located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ (SHL) of Section 4, T.24S., R.30E., unit tract No. 43, Lease No. NMLC068431, and in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ (BHL) of Section 10, T.24S., R.30E., unit tract No. 45, Lease No. NMLC068905, with an initial potential of 660 BOPD and 657 MCFPD from the Delaware Formation. The well was completed on November 29, 2012.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" is returned herewith. Please advise all interested parties of the approval of the Second Revision to the Consolidated Delaware Formation Participating Area "BDEFH" effective as of November 1, 2012.

Any production royalties that are due must be reported and paid within 30 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (30 CFR 218.54). 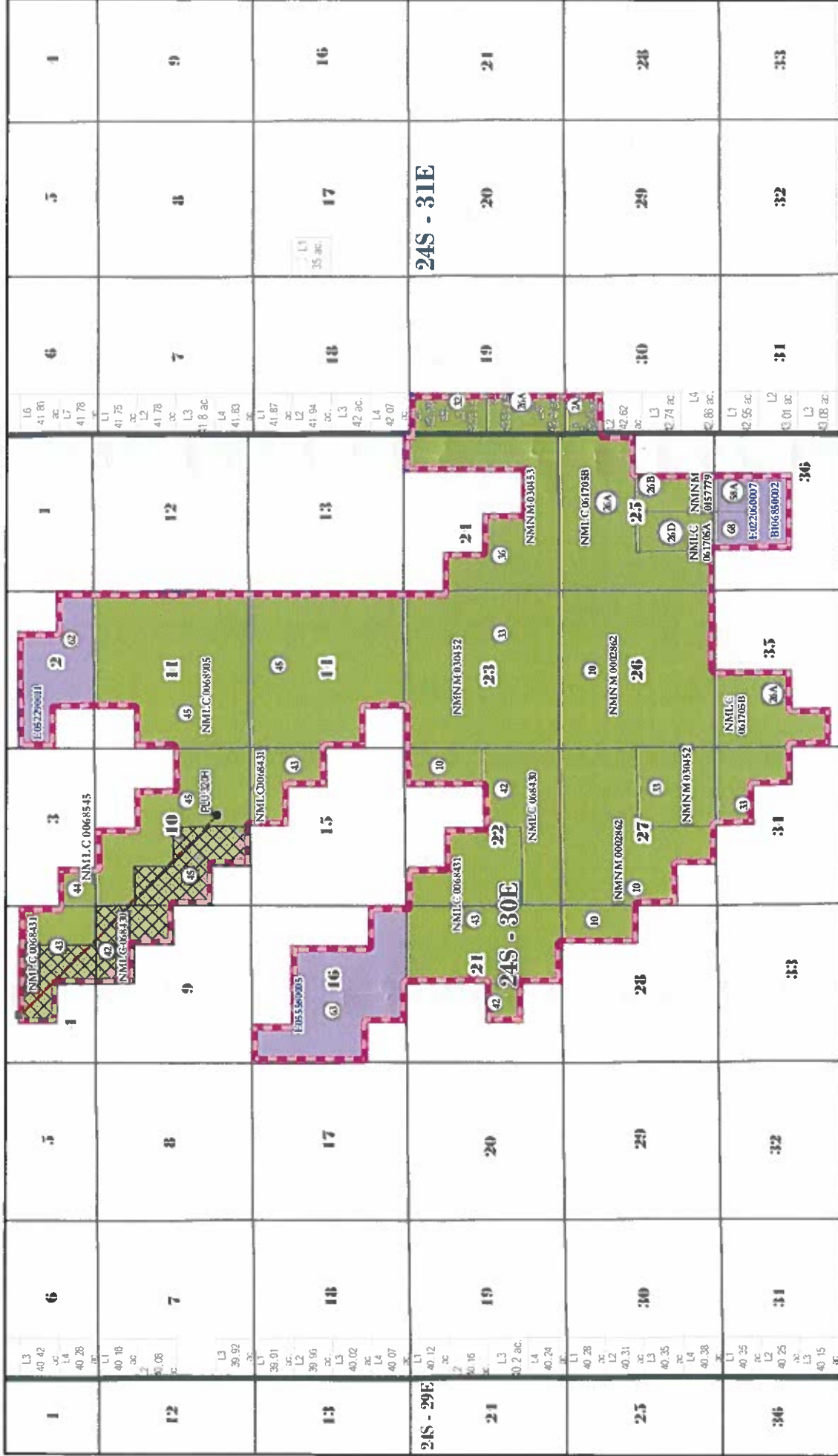
