- 2 EXAMINER BRANCARD: With that I call Item 15 on
- 3 the agenda today, Case 22117, Franklin Mountain Energy.
- 4 MS. BENNETT: Good morning, Mr. Examiner. Deana
- 5 Bennett on behalf of Franklin Mountain Energy, LLC
- 6 EXAMINER BRANCARD: Are you doing this one
- 7 separate from the next two cases, Ms. Bennett?
- 8 MS. BENNETT: Yes. Thank you for asking. I
- 9 would actually like to put these cases on separately,
- 10 because these cases end up having different details that I
- 11 would like to walk the Division through.
- 12 EXAMINER BRANCARD: So are there any other
- 13 parties or interested persons in Case 22117? (Note:
- 14 Pause.)
- 15 Hearing none, please proceed, Ms. Bennett.
- MS. BENNETT: Thank you.
- 17 Just out of an abundance of caution, I
- 18 do have Ms. Albrecht, Shelly Albrecht, with us in case the
- 19 Division has any questions -- but we can turn to that if
- 20 there are any questions for her -- and she's a land
- 21 professional for Franklin Mountain Energy.
- 22 In Case No. 22117, this is a companion case
- 23 two other cases we are putting on today and three cases
- 24 that I put on two weeks ago, and these six cases all
- 25 involve Franklin Mountain Energy's Colorado Well Group.

In the cases that went last week, or two

- 2 weeks ago, excuse me, Franklin Mountain Energy was seeking
- 3 extensions of time to drill the wells, and those
- 4 extensions were granted and Orders were issued yesterday.
- 5 So this is a companion case to the cases for which Orders
- 6 were granted yesterday.
- 7 This case is slightly different, though.
- 8 In this case Franklin Mountain Energy is seeking to pool
- 9 only the overriding royalty interest owners in the east
- 10 half of the east half of Sections 9 and 4, Township 24
- 11 South, Range 35 East.
- 12 As noted in Ms. Albrecht's Declaration,
- 13 Franklin Mountain Energy has 100 percent participation of
- 14 the working interest owner in this unit, so Franklin
- 15 Mountain Energy only needs to pool the overriding royalty
- 16 interest owners.
- I have included in the packet of materials
- 18 Ms. Albrecht's Declaration. She has previously been
- 19 qualified as an expert by the Division, previously
- 20 testified before the Division, and her exhibits contain
- 21 the, what I call sort of a summary of the usual -- or
- 22 condensed version of the usual exhibits. Because Franklin
- 23 Mountain Energy is only seeking to pool overrides, we did
- 24 not include the Proposal Letters or AFEs because Franklin
- 25 Mountain Energy is not asking for any costs or penalties,

- 1 the risk charge in this case.
- 2 But I did include the Compulsory Pooling
- 3 Checklist as Exhibit A. I also included with Ms.
- 4 Albrecht's Declaration the C-102 for the wells.
- 5 Franklin Mountain Energy is proposing two
- 6 wells for this unit, the Breckenridge Fed Com 304H well
- 7 and the Breckenridge Fed Com 604H well.
- 8 And I've also included with Ms. Albrecht's
- 9 Declaration a Notice Affidavit prepared by me that shows
- 10 that Notice of this hearing was provided to the overriding
- 11 royalty interest owners that Franklin Mountain Energy is
- 12 seeking to pool. We sent Notice Letters and also
- 13 published, out of an abundance of caution, and both the
- 14 Notice Letters and Publication Notice are behind my
- 15 affidavit.
- 16 Also included as Exhibit 4 is the lease
- 17 tract map, and the lease tract map identifies the leases
- 18 at issue, as well as identifying the overriding royalty
- 19 interest owners that Franklin Mountain Energy seeks to
- 20 pool in this case.
- The next set of exhibits behind Ms.
- 22 Albrecht's Declaration are the geology exhibits prepared
- 23 by Ben Kessel. Ben Kessel is Franklin Mountain Energy's
- 24 Geologist. He has previously testified before the
- 25 Division and his credentials have been accepted as a

- 1 matter of record.
- Behind his Declaration I have included the
- 3 usual suite of geology exhibits, including a locator map,
- 4 a wellbore schematic that shows all of the wells that are
- 5 part of Franklin Mountain Energy's Colorado unit. And
- 6 then I've included two geology studies: One for the 304H
- 7 well, which is a First Bone Spring well, and one for the
- 8 604H well, which Franklin Mountain identifies as a Third
- 9 Bone Spring well.
- 10 So we've included the usual exhibits there,
- 11 a structure map, cross section locator map, cross section,
- 12 and a gross isopach.
- We've also included with Mr. Kessel's
- 14 exhibits an excerpt from the Snee, Zobach bach paper to
- 15 justify the orientation of the wells.
- 16 With that I would ask that the exhibits for
- 17 Case No. 22117 be accepted into the record, and I will
- 18 pause for any questions.
- 19 EXAMINER BRANCARD: Thank you. Mr. Lowe, any
- 20 questions?
- 21 EXAMINER LOWE: I do have a question for Ms.
- 22 Bennett.
- Good morning, Ms. Bennett.
- MS. BENNETT: Good morning, Mr. Lowe. Nice to
- 25 hear you today.

- 1 EXAMINER LOWE: Nice to hear you, too.
- I just want to get a clarification to
- 3 what's going on here. For this particular case you're
- 4 indicating that you're noticing the overriding royalty
- 5 interests in the east half of the east half of this
- 6 location here? Is that what you...
- 7 MS. BENNETT: That's right.
- 8 EXAMINER LOWE: Are you just adding it on or did
- 9 you guys change stuff on your end, or was it just -- how
- 10 did that come about to the situation?
- MS. BENNETT: Good question.
- 12 So these -- the Colorado cases originally
- 13 went to hearing a couple of years ago, and at that time
- 14 because Franklin Mountain Energy had all of the working
- 15 interests committed to the wells, we elected not to pool
- 16 the override. But upon further reflection, given the fact
- 17 that we had additional Colorado cases going to hearing
- 18 again, we determined to pool just the overrides in this
- 19 case.
- 20 So that's why this case is a new case, but
- 21 it's part of a development that has been proposed by
- 22 Franklin Mountain Energy for a couple of years now.
- 23 EXAMINER LOWE: Okay. What do you mean by the
- 24 Colorado case?
- 25 MS. BENNETT: These cases are part of what

- 1 Franklin Mountain Energy refers to as their Colorado
- 2 Cases. The wells all have names of Colorado towns, like
- 3 Breckenridge and Ouray, Golden. So Franklin Mountain
- 4 Energy has grouped their development plans by categories,
- 5 and this is the Colorado Well Group family unit.
- 6 EXAMINER LOWE: Okay. Thank you for the
- 7 answers. That's all I have?
- MS. BENNETT: Thank you, Mr. Lowe.
- 9 EXAMINER BRANCARD: Thank you, Mr. Lowe.
- 10 So here is today's first lesson of future
- 11 practice tips for attorneys.
- 12 So when I go into the case file, Ms.
- 13 Bennett, there appears a second filing, which is a
- 14 checklist, a new checklist, in 22117.
- 15 MS. BENNETT: Yes. And that is because we filed
- 16 the exhibits timely on Tuesday, but after we filed the
- 17 exhibits we noticed there was a typo in the first page of
- 18 the Compulsory Pooling Checklist. And I coordinated with
- 19 Ms. Salvidrez about how best to approach the typo and
- 20 suggested that we would prepare a corrected first page of
- 21 the compulsory pooling checklist, and this is what's in
- 22 the file as the, I think that you're referring to. I
- 23 don't have the well file in front of me, I'll open it up,
- 24 but I think that's what you're referring to.
- 25 EXAMINER BRANCARD: So in discussion with the

- 1 examiners, we decided that if you are going to file
- 2 something like this, if you're going to file a corrected
- 3 exhibit, say prior to the hearing, you really need to have
- 4 a cover sheet, because all that pops up in the well file
- 5 is this checklist. We have no idea who filed it, why they
- 6 filed it. Presumably it's designed to replace the exhibit
- 7 that's already in your listed exhibits. That's fine.
- 8 Just say that.
- 9 And it's really helpful if you indicate
- 10 what the change is, because otherwise we sit here and
- 11 stare at two versions of the checklist trying to figure
- 12 out what exactly you changed.
- So that's just going forward, please any
- 14 time you submit a document into our well file, into the
- 15 portal, put a cover sheet on it. Don't just put the
- 16 document. If we ask you to submit an amended exhibit
- 17 after the hearing, because these exhibits are part of an
- 18 Affidavit presentation we would like another short
- 19 affidavit as the cover document. Okay? That and again
- 20 just says what it is, what was changed. It doesn't have
- 21 to be very long. And here we give a gold star to this
- 22 week Ms. Hardy did just that in response to a request that
- 23 we had on one of her cases following up on information.
- 24 It was very simple. It's a changed checklist. She
- 25 submitted a short, less-than-one-page affidavit, indicated

1 what it was, what got changed. And that was really good.

- 2 So that will be really helpful to us going
- 3 forward so when we go back to these files -- and I have to
- 4 admit it's not necessarily the people who are sitting here
- 5 like Mr. Lowe who will end up writing the Order. It will
- 6 often be somebody different helping out or actually
- 7 writing the Order. So it's particularly helpful to them.
- 8 Or if we have to go back to a case sometime
- 9 in the future, then to know what these submittals are.
- 10 Anyway. So much for that lecture.
- 11 The other point I noticed in your checklist
- 12 is, you guys, Franklin really likes to talk about this
- 13 Colorado Group here, and you refer to the well family as
- 14 Colorado. I believe the well family is the name of the
- 15 wells in this case, which I don't know if these are the
- 16 Breckenridge. So I think Breckenridge is technically the
- 17 well family.
- 18 So anyway --
- MS. BENNETT: Thank you.
- 20 EXAMINER BRANCARD: -- thank you for all that.
- 21 Are there any other comments on Case 22117?
- 22 Hearing none, that case is submitted and
- 23 taken under advisement, and the exhibits are admitted.
- 24 Thank you.
